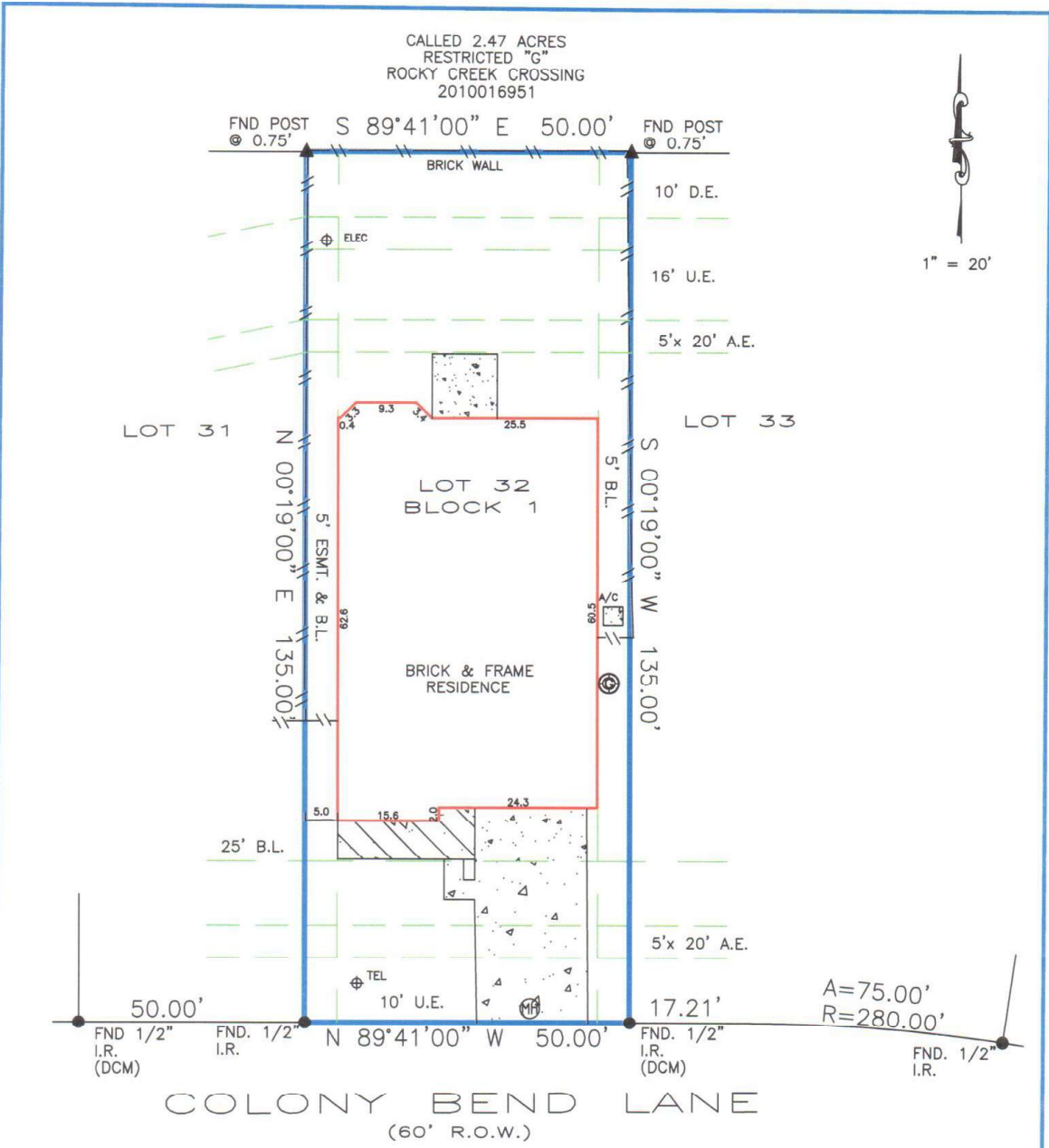


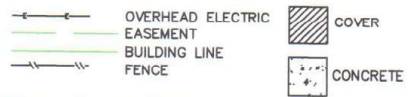




COLONY BEND LANE
