THENCE S 03° 59' 29" E, along the common line between said Baker called 1.05 acres and said Heuer called 7.88 acres, at 21.25 ft. pass a 5/8" iron rod found for reference, and in all a total distance of 291.37 ft. to a 5/8" iron rod found marking the southeast corner of said called 1.05 acres, a corner of said called 7.88 acres and the northeast corner of the 1.06 acre residue of said Baker called 8.944 acres, said point being an angle point in a western line of the herein described 50.24 acre tract;

THENCE S 03° 35′ 08" E 50.79 ft. along an eastern line of said called 48.12 acres, same being the west margin of said Castlewood Road, to a 5/8" iron rod found marking an angle point in said line;

THENCE S 02° 11′ 34″ E, along an eastern line of said called 48.12 acres, same being the west margin of said Castlewood Road, at 550.65 ft. pass a 5/8″ iron rod found for reference, and in all a total distance of 564.18 ft. to a point in the centerline of a creek representing the east common corner between said Baker called 48.12 acres and the called 7.344 acres described in deed to Bryan Geoffrey Pauls and Kathryn L. N. R. R. Survey, A-681, in all a total distance of 383.46 ft. to a 3/8" iron rod found marking the west common corner between said tracts, same being the west common corner between Lots 27 and 26 of said Rollingwoods, located in the east line of the 98.313 acres described in deed to Ted R. Schaller and wife, Melodee L. Schaller, recorded in Volume 1529, Page 871 of said Official Records, said point being the most southern southwest corner of the herein described 50.24 acre tract;

THENCE N 01° 11' 11" W 40.69 ft. along the common line between said Baker called 48.12 acres and said Schaller 98.313 acres, same being the west line of said Lot 27 of Rollingwoods, to a concrete monument found marking an interior corner of said Baker tract and the northeast corner of said Schaller tract located in the north line of said I. & G. N. R.R. Survey and the south line of said Smith Survey, said point being an interior corner of the herein described 50.24 acre tract;

THENCE S 88° 34' 33" W 109.88 ft. along the common line between said Baker called 48.12 acres and said Schaller 98.313 acres, same being the common survey line between said I. & G. N. R. Survey and said Smith Survey, to a 5/8" iron rod found marking the south common corner between said Baker tract and the called 46 acres described in deed to Giacomo Reginato and wife, Giuseppina Reginato, recorded in Volume 1563, Page 859 of said Official Public Records, said point being the most western southwest corner of the herein described 50.24 acre tract;

THENCE N 00° 21' 45" E 2,172.42 ft. along the common line between said Baker called 48.12 acres and said Reginato called 46 acres to a concrete monument found marking the

THENCE N 01° 51' 21" W, along the west lines of said 1.06 acre residue tract and said Baker called 1.05 acres, common in part with the east lines of said Reginato called 46 acres and said Wells called 4.00 acres, at 563.33 ft. pass a concrete monument found for reference, and in all a total distance of 586.07 ft. to place of beginning and containing within these bounds 50.24 acres of land as shown on a plat accompanying this description.

Bearings for this survey are based on deed call for the west line of the called 48.12 acres described in deed to James M. Baker recorded in Volume1768, Page 307 of the Polk County Official Records.
