Addendum 1

9003 Dunlap has only flooded 1 time – during Harvey. Water rose and left the house in less than 12 hours. Carpet and sheetrock were removed within 72 hours. The family room had wood paneling which was removed to the ceiling. The rest of the house had sheetrock removed to the 4 foot level. Water did not reach up to electrical outlet height. The house was dried with dehumidifiers and fan forced air for approximately 2 weeks. Moisture levels in the studs tested acceptable. Before sheetrock was replaced, the studs were treated with both concrobium and KILZ. It was not a “certified treatment company” and no mold certificate is available.
