
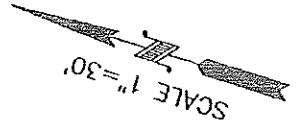
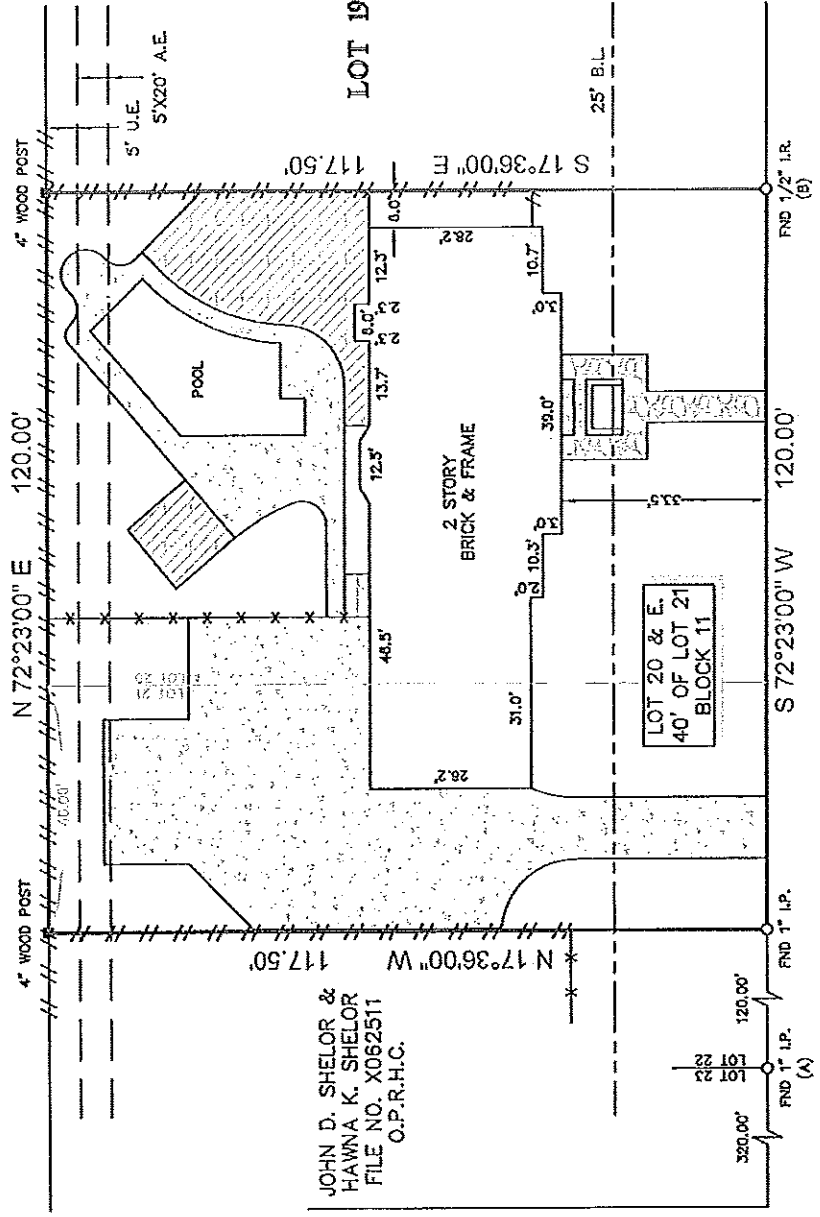

 (100' R.O.W.)

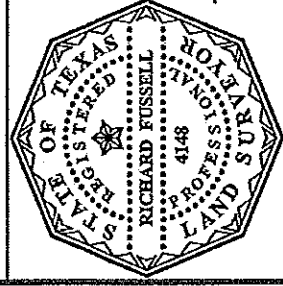


