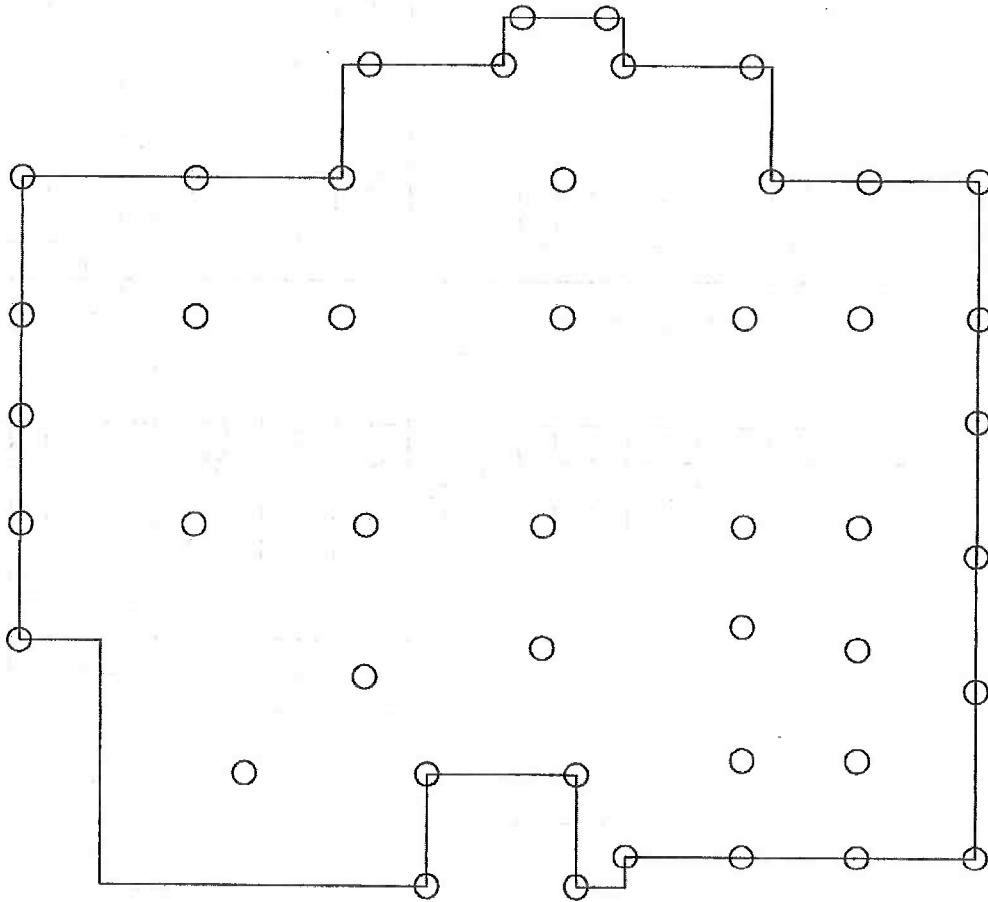
- 1) Property had over 40 exterior and interior piers of Foundation Repair. The repair was done by Trinity Foundation and it carries a full lifetime warranty that is fully transferable. The company has explained to us that the piers would be covered 100%, even though the warranty states a \$75 fee per pier. (Please call Trinity Foundation for further details).
- 2) A plumbing issue may have caused the foundation issue.
- 3) The entire sub-slab plumbing was changed by the same Foundation Company, and that warranty is carried for 3 years, per the company. (Please call Trinity Foundation for further details).
- 4) The following items were added and changed along the full foundation and plumbing repairs of June 2017. It was a total of over \$25,000 in repairs.
 - Entire downstairs tile.
 - Entire carpet upstairs
 - Front door
 - Glass shower door
 - Estimated half of the sq ft of sod in the backyard.
- 5) A claim was pulled due to the plumbing issue that caused the foundation repair with Liberty Mutual.
- 6) The home had about \$35,000 in repairs in 2012 as well.

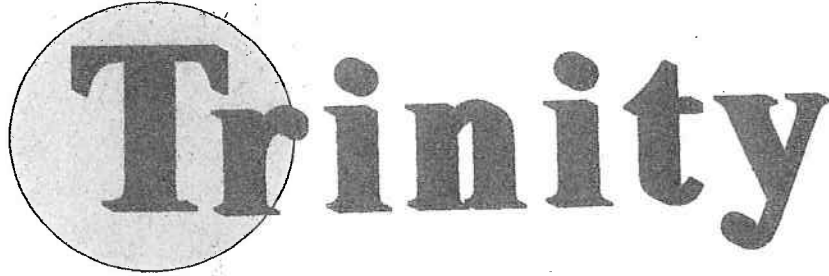
