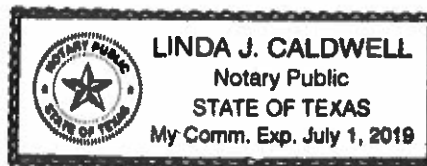
4. To the best of our actual knowledge and belief, since June 2010 there have been no:
