


# Notice to a Purchaser of Real Property in a Water District

1) The real property, described below, that you are about to purchase is located in the Harris-Montgomery Counties MUD # 386 District. The district has taxing authority separate from any other taxing authority and may, subject to voter approval, issue an unlimited amount of bonds and levy an unlimited rate of tax in payment of such bonds. As of this date, the rate of taxes levied by the district on real property located in the district is \$.465 on each \$100 of assessed valuation. If the district has not yet levied taxes, the most recent projected rate of tax, as of this date, is \$.465 on each \$100 of assessed valuation.
