 The house had minor water penetration through the weep holes. Only 15-20% of the laminate floor experienced warping due to the Hurricane Harvey storm Aug 2017. All downstairs laminate was removed and replaced. The house had no standing water or flooding due to the hurricane or any time prior. The house is zoned in a low risk 500 year flood plain.

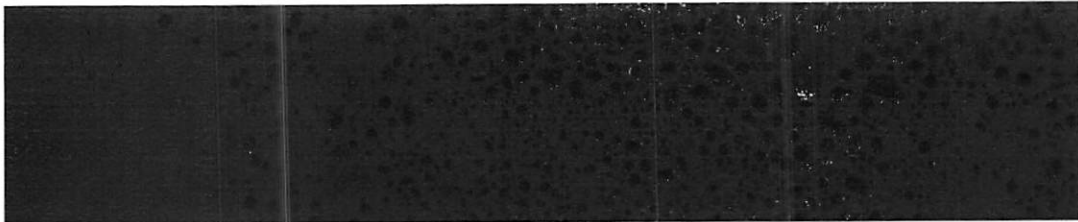
