


FIELD NOTE DESCRIPTION OF A 1,335.2230 SQUARE FEET TRACT OF LAND OUT OF OUTLOT 197, OF ALTA LOMA OUTLOTS, A SUBDIVISION IN GALVESTON COUNTY, TEXAS, ACCORDING TO THE MAP OR PLAT THEREOF, RECORDED IN VOLUME 113, PAGE 9 AND TRANSFERRED TO PLAT RECORD 10, MAP NO. 21 IN THE OFFICE OF THE COUNTY CLERK OF GALVESTON COUNTY, TEXAS AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING at the Southeast corner of Outlot 197 on the North right-of-way line of 32nd. Street (40' R.O.W.) and the South line of a 10 feet wide right-of-way granted to Galveston County as recorded in Volume 917, Page 529 in the Office of the County Clerk of Galveston County, Texas;

THENCE NORTH a distance of 10.00 feet to a 5/8-inch iron rod found on the North right-of-way line of said 10 feet wide right-of-way, same being the Southeast corner of a call 2.1130 acre tract of land conveyed to Chris Pledger, et ux, as recorded under Galveston County Clerk's Film Code No. 010-63-0629;

THENCE WEST along the South line of said 2.1130 acre tract of land, a distance of 142.06 feet to a 1/2-inch iron rod set with a cap stamped "True Meridian" for the PLACE OF BEGINNING;

THENCE WEST a distance of 15.54 feet to a 1-1/2 inch iron pipe found at the Southwest corner of said 2.1130 acre tract of land;

THENCE NORTH along the West line of said 2.1130 acre tract of land, a distance of 100.76 feet to a 1/2-inch iron rod set with a cap stamped "True Meridian" for corner;

THENCE S 27°36'29" E a distance of 33.54 feet to an 8-inch fence post for and angle point;

THENCE SOUTH a distance of 71.04 feet to the PLACE OF BEGINNING and containing 1,335.2230 square feet of land, more or less.
