

40.000 Acres R. Allphin Survey, A-1 Madison County, Texas

Being 40.000 acres of land out of a called 71.02 acre tract as described in Volume 659, Page 289 and a called 8.88 acre tract as described in Volume 1132, Page 63 of the Official Records of Madison County, Texas, also located in the R. Allphin Survey, A-1, Madison County, Texas, said 40.000 acres being more particularly described by metes and bounds as follows:

BEGINNING at 3/8" iron rod found at an angle point of the above mentioned 71.02 acre tract and being the southwest corner of the herein described tract;

THENCE North 01 degrees 50 minutes 03 seconds West, a distance of 917.44 feet to a 5/8" iron rod found for the southwest corner of said 8.88 acres and an angle point of herein described tract;

THENCE North 01 degrees 44 minutes 27 seconds West, a distance of 67.56 feet to a point in the east line of F.M. 2346 for an angle point of herein described tract;

THENCE with a curve to the left along the east line of F.M. 2346 having a radius of 1,195.89 feet and a length of 409.17 feet (North 06 degrees 48 minutes 34 seconds East, 407.18 feet) to a point from which a TXDOT concrete monument bears N38°52'56"W, 0.57';

THENCE North 02 degrees 45 minutes 37 seconds West, with the east line of F.M. 2346, a distance of 225.46 feet to a TXDOT concrete monument found for the northwest corner of herein described tract;

THENCE North 83 degrees 45 minutes 21 seconds East, a distance of 680.71 feet to a point for the northeast corner of herein described tract;

THENCE South 06 degrees 14 minutes 39 seconds East, a distance of 754.54 feet to a point for an angle point of herein described tract;

THENCE South 26 degrees 07 minutes 48 seconds East, a distance of 946.50 feet to point for the most easterly corner of herein described tract;


THENCE South 32 degrees 00 minutes 28 seconds West, a distance of 701.09 feet to a point for the most southerly corner of herein described tract;
