4. To the best of our actual knowledge and belief, since 9/1/1992 there have been no:

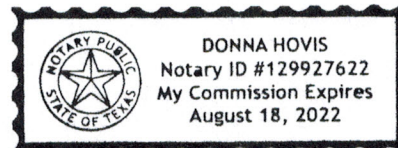
- a. construction projects such as new structures, additional buildings, rooms, garages, swimming pools or other permanent improvements or fixtures;

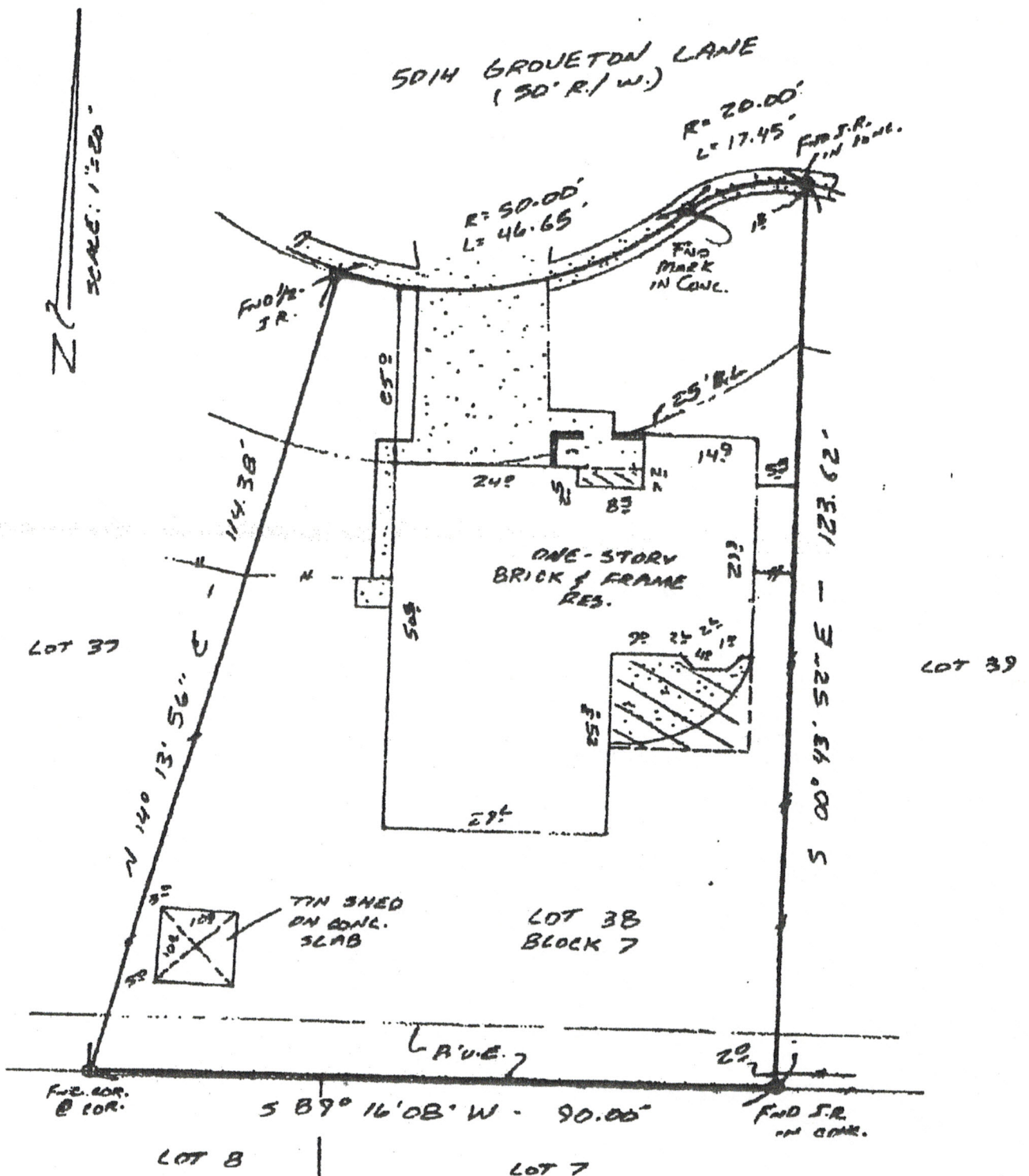
