POOL HOURS

- The pool will be closed on Mondays for cleaning except on holiday weekends (closed on Tuesday for cleaning on holiday weekends).

TRASH PICK-UP

Residents may contract with a Waste Management Company for trash pick-up. Due to damage to the sides of the roads by the trash trucks, it is imperative that everyone place their issued trash container at least 18 inches from the grass line onto the pavement so that trucks do not have to pull over into the dirt and grass leaving ruts.

GATE CARD

Broken or damaged cards will be replaced at no charge. You will need to bring your broken or damaged card to the HVLOA Clubhouse Office.
