

Two minor leaks from previous roof; new roof installed in 2018 (see section 2 of this disclosure).

During major rain events, a little rainwater penetrated the sun room under exterior door. The door threshold's rubber parts had dry rot, and door lacked weatherstripping; these items were repaired July-Aug. 2019. There was no damage, as the rainwater only resulted in a small puddle on concrete floor. Owner has not been onsite during a major rain event since repairs were completed.
