Being that certain tract or parcel of land situated in Lot 179, in Section No. 2 of the Trimble and Lindsey Survey of Galveston Island, In Galveston County Texas, and being more particularly described by metes and bounds as follows:

COMMENCING at the Southwesterly corner of said Lot 179, Section No. 2, Trimble and Lindsey Survey;

THENCE North 25' 00' West along the West line of said Lot 179, a distance of 1329.00 feet to the Southerly line of Sportsman Road (100' right—of—way), a found 1" pipe;

THENCE North 25' 00' West continuing along the West line of said Lot 179, a distance of 116.2 feet to the North right-of-way line of said Sportsman Road;

THENCE North 83' 13' East, along the North line of said Sportsman Road, a distance of 98.2 feet to a point for corner on the North line of said Sportsman Road;

THENCE North 76' 30' East, continuing along the North right—of—way line of said Sportsman Road, a distance of 150.1 feet to the PLACE OF BEGINNING of the herein described tract, a found 1/2 inch rod bearing S 45 W a distance of 1.6', same being the Southeast corner of a tract of land conveyed to Matthew and Sydney Murphy as recorded in Galveston County Clerk's File No. 2012015620 in the Official Public Records of Real Property of Gavleston County, Texas;

THENCE N 25° 00' West, along the East line of said Murphy tract, at 123.7 feet passing a cut 'x' in concrete bulkhead, a total distance of 128.27 feet to the South shoreline of Galveston West Bay;

THENCE North 73° 02' East, along the shoreline of said Galveston West Bay, a distance of 50.47 feet;

THENCE South 25° 00' East, at 2.8' passing a set nail, a total distance of 131.38' to the North right—of—way line of said Sportsman Road, a set 1/2 inch rod;

THENCE S 76* 30 West, along the North right—of—way line of said Sportsman Road, a distance of 51.00 feet to the PLACE OF BEGINNING, and containing 0.149 acres of land more or less.
