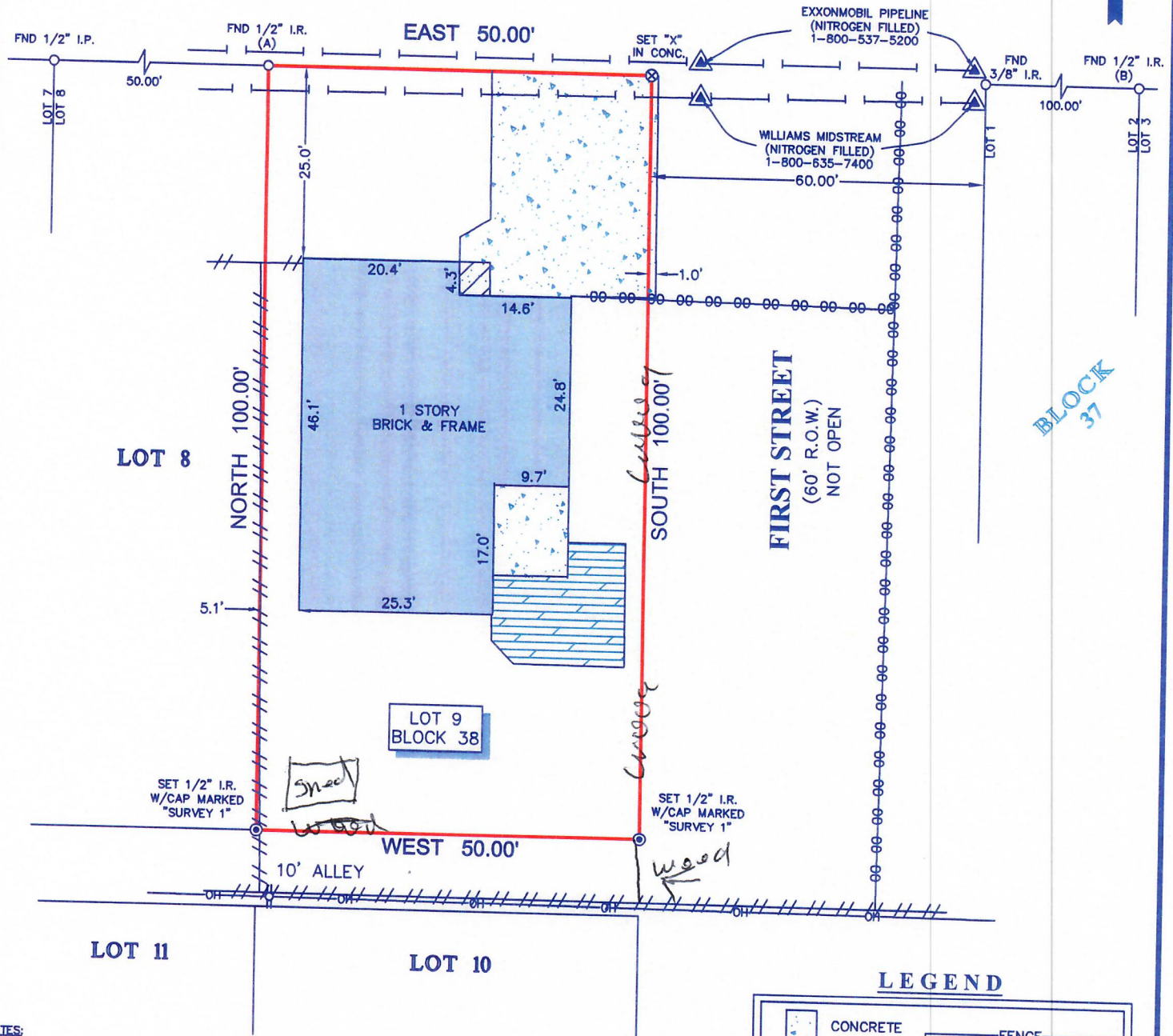

### 30TH AVENUE NORTH (60' R.O.W.)

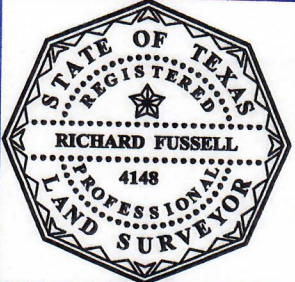
