2.86 ACRES

These notes describe that certain 2.86 acres in the N. C. KILLOUGH SURVEY, Abstract 460, located in Leon County, Texas; being all of "Tract One – 2.855 acres" contained in a General Warranty Deed dated February 13, 2019 from John Bankhead et al to David W. Free and recorded in Volume 1750 Page 531 Leon County Official Records; this 2.86 acre tract is described more particularly as follows:

BEGINNING at the Southwest corner of the "2.855 acres", same being for the upper Southeast corner of that "106.99 acres" (recorded in Volume 1123 Page 363 LCOR), same being; set a ½" steel rod (with yellow cap marked D W FREE RPLS 4010) at same; found a 3/8" steel rod (no cap) bearing North 80°-26'-06" West 318.57 feet from which another 3/8" steel rod (no cap) was found bearing South 10°-16'-35" East 1,190.57 feet;

THENCE with the West line of the "2.855 acres", same being the East line of the "106.99 acres", partially along old fence remnants, North 09°-38'-12" East a distance of 1,046.79 feet to the North corner of the "2.855 acres" in County Road 318 (but not the centerline of same); set a ½" steel rod (with yellow cap marked D W FREE RPLS 4010) offset South 09°-38'-12" West 128.20 feet;

THENCE with line of the "2.855 acres" in County Road 318 (but not the centerline od same), as follows:

South 00°-31'-30" West 255.20 feet to a ½" steel rod (with yellow cap

marked D W FREE RPLS 4010) set below

surface;

South 06°-14'-29" East 639.20 feet to a ½" steel rod (with yellow cap

marked D W FREE RPLS 4010) set below

surface;

South 02°-25'-53" West 182.14 feet to the Southeast corner of the

"2.855 acres"; set a $\frac{1}{2}$ " steel rod (with yellow

cap marked D W FREE RPLS 4010) offset

North 80°-11'-38" West 27.60 feet;

THENCE with the South line of the "2.855 acres", North 80°-11'-38" West a distance of 238.14 feet to the PLACE OF BEGINNING.

Containing, according to the dimensions herein stated, an area of 2.86 acres of land.
