AMENDMENT TO RESTRICTIONS

THE STATE OF TEXAS

COUNTY OF HARRIS

WHEREAS, the undersigned are a majority of the owners of all of the lots located and situated in:

GLENLOCH ADDITION, SECTION TWO (2), a subdivision in Harris County, Texas according to the map or plat thereof recorded in Volume 166, Page 40, of the Map Records of Harris County, Texas

(hereinafter referred to as the "Subdivision"); and

WHEREAS, certain instruments establishing restrictive covenants and amendments thereto (hereinafter referred to as the "Restrictions") affecting residential lots in the Subdivision have been filed and recorded in the real property records of Harris County, Texas under the following recording references:

Volume 7903, Page 322, Deed Records of Harris County, Texas and County Clerk's File No. D594022, Film Code No. 144-32-2489 in the Official Public Records of Real Property of Harris County, Texas

which said instruments are incorporated herein and made a part hereof by reference;

WHEREAS, the Restrictions establish and subject each residential lot in the Subdivision to an annual maintenance charge not to exceed \$5.00 per month or \$60.00 per annum for the purposes of creating a "maintenance fund", and

WHEREAS, the aforesaid maintenance charge is inadequate for future needs of the Subdivision;

NOW, THEREFORE, the undersigned agree to change the "Restrictions" as follows:

MAINTENANCE CHARGE INCREASE

As of the effective date hereof, the provisions of $\underline{\text{MAINTENANCE CHARGE}}$ of the Restrictions which reads "Each Lot in Glenloch Addition, Section Two (2), is hereby subjected to an annual maintenance charge and assessment not to exceed \$5.00 per month or \$60.00 per annum"... is hereby amended to be "Each Lot in Glenloch Addition, Section Two (2), is hereby subjected to an annual maintenance charge and assessment not to exceed \$10.00 per month or \$120.00 per annum,"... and the provisions of said article which reads ... "provided that said assessment will be uniform and in no event will such assessment or charge exceed \$5.00 per Lot per month, or \$60.00 per Lot per year." is hereby amended to be ... "provided that said assessment will be uniform and in no event will such assessment or charge exceed \$10.00 per Lot per month, or \$120.00 per Lot per year."

The aforesaid increase in maintenance charge shall be effective as of January 1, 1980, providing a similar increase is made to the maintenance charge for GLENLOCH ADDITION, SECTION 1; MEMORIAL CHASE, SECTION 1; MEMORIAL CHASE, SECTION 2; and MEMORIAL CHASE, SECTION 3; all of which are additions in Harris County, Texas according to the maps or plats thereof recorded in the following Volumes and Pages, respectively, of the Harris County Map Records, to wit:

Volume 162, Page 121; Volume 192, Page 22; Volume 239, Page 23; and Volume 210, Page 1.

The aforesaid Restrictions, as amended hereby, are ratified and confirmed and the provisions of the maintenance charge increase above set forth shall have the same force and effect as if originally set forth in said Restrictions with an effective date for the increase of January 1, 1980.
