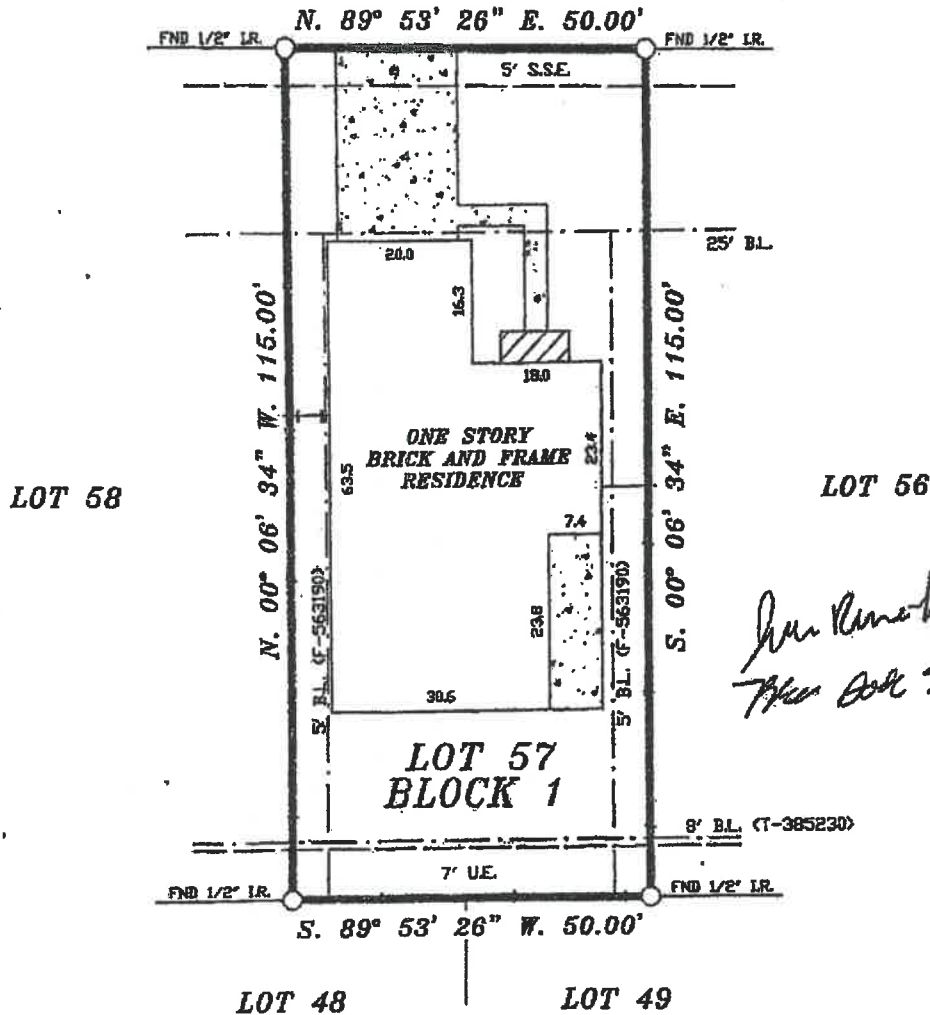


MOONLIT MEADOWS COURT (50' R.O.W.)

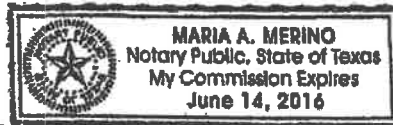
