All that certain tract or parcel of land situated in Lee County, Texas being a part of the Claiborne Lawrence Survey, Abstract No. 189, being all the residue of a called 112.5 Acre tract conveyed from Mrs. Jennie King, et al to Louis Morganstern by deed dated March 23, 1964 and recorded in Volume 154, Page 339 of the Deed Records of Lee County, Texas and being more particularly described by metes and bounds as follows to wit:

**<u>BEGINNING</u>** at a set 1/2" iron rod (with red plastic cap marked "TRIAD RPLS 5952") on the east Right-of-Way line of F.M. Highway 141, at the south corner of a called 109 Acre tract conveyed to Douglas Spacek in Vol. 70, Pg. 463, for the west corner of this tract;

THENCE N 42°01 '27" E - 2342.31 feet along the southeast lines of the said 109 Acre tract and a called 47.541 Acre tract conveyed to Lee Ellen Flippin in Vol. 1123, Pg. 001, respectively, to a set 1/2" iron rod (with red plastic cap marked "TRIAD RPLS 5952") at the east corner of the said 47.541 Acre tract, at the south corner of a called 113.5 Acre tract conveyed to Ronald L. Dossey in Vol. 56, Pg. 195, at a west corner of a called 264.3 Acre tract conveyed to Sixteen Ninety-Seven, LTD. in Vol. 791, Pg. 538, for the north corner of this tract;

**THENCE** along the southwest and northwest lines, respectively, of the said 264.3 Acre tract and a called 80 Acre tract conveyed to Benie Langhorn and a called 25.52 Acre tract conveyed to Mary E. Schumacher in Vol. 572, Pg. 581, respectively, for the following courses and distances:

S 48°51′01″E - 545.79 feet to a 20" post oak tree for an exterior ell corner of this tract; S 43°17′06″W - 412.10 feet to a 20" post oak tree for an interior ell corner of this tract; S 46°49′49″E - 1144.35 feet to a 20" post oak tree for the east corner of this tract; S 42°08′12″W - 3331.80 feet to a set 1/2" iron rod (with red plastic cap marked "TRIAD RPLS 5952") on the said east Right-of-Way line of F.M. Highway 141, at the west corner of the said 25.52 Acre tract, for the south corner of this tract;
