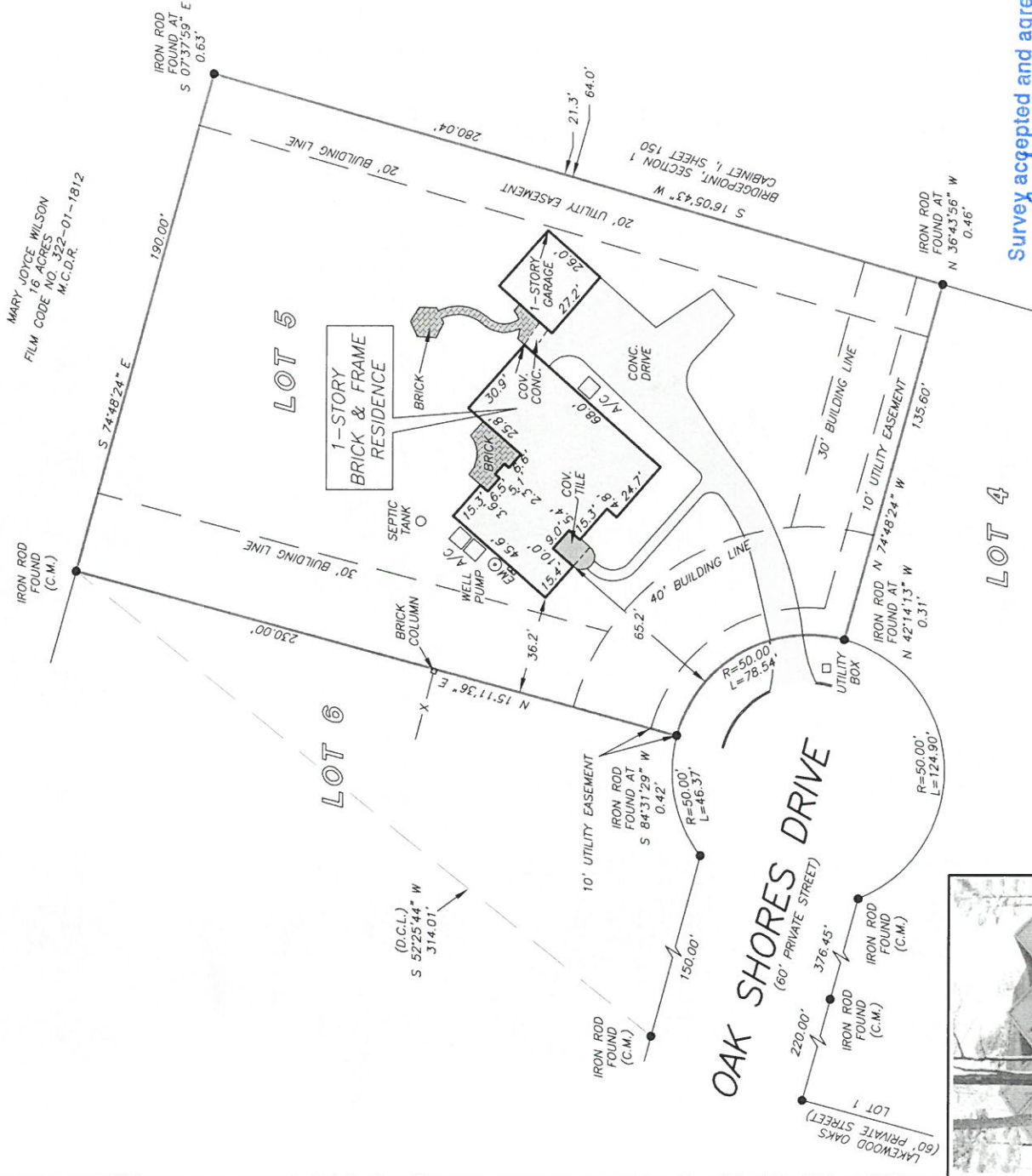

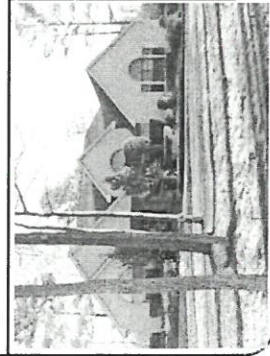


LOT 5 LAKEWOOD ON LAKE CONROE
