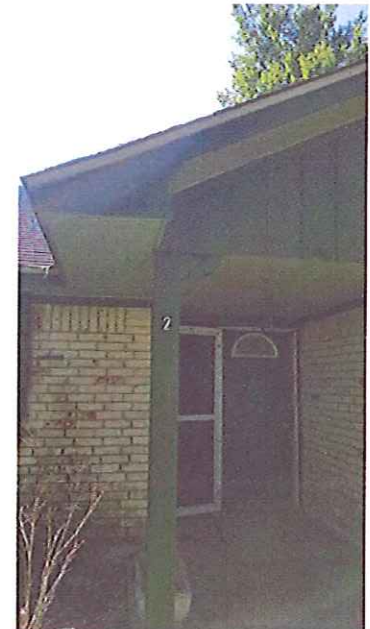


Photo One Caption FRONT VIEW - TAKEN 8/11/18

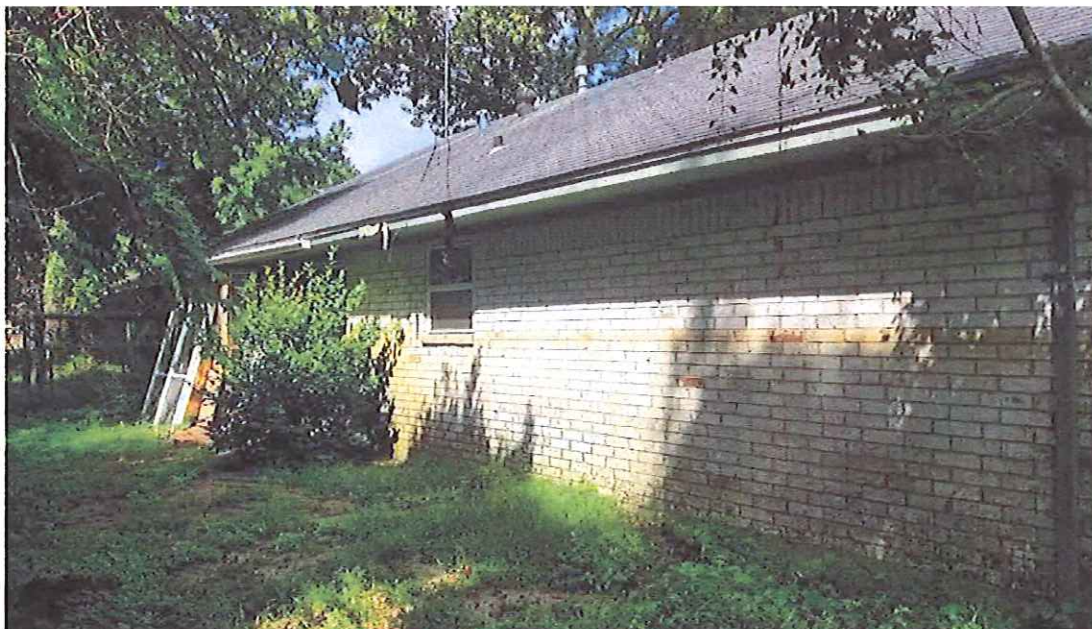


Photo Two Caption REAR VIEW - TAKEN 8/11/18
