

Thank you for your interest in living at the Blackbeard Apartments

- Each person over the age of 18 who will occupy the premises is required to complete an application and pay the \$50.00 application fee.
- Credit, criminal and eviction histories will be generated. After the application and application fee are received, you will receive an email from TransUnion/MySmartMove allowing them to provide us with your information.
- Pets are allowed on a case by case basis, maximum of 2 pets per apartment, 50-pound combined weight maximum. Shot records required, any cats must be declawed. There is a \$250.00 per pet, nonrefundable pet fee.
- Apartment will not be held from showings or other rentals until such time as
 application, application fee, security deposit and 3 month's of paystubs or other
 verification of income/ability to pay are received. If the tenant(s) are not accepted for
 any reason, the deposit will be refunded.
- Please see the attached rules of the complex which will also accompany the lease when signed.
- Rent is \$900/month + all utilities on a 1-year lease, and \$975/month + all utilities for a 6 or 9 month lease. Tenants will have 3 business days to have utilities transitioned to their own names.
- Security deposit equal to 1st month's rent. Higher security deposit may be required dependent upon results of background check information received by landlord.
- If rent is pro-rated for move in on a day other than the 1st of the month, it is the 2nd month that is prorated.
- If you are represented by a Real Estate Agent or Broker, their name and information must appear on the initial Residential Lease Application for their commission to be earned.
- My Galveston Getaway, Inc., on behalf of the property owner, will prepare and execute the lease agreement.
