Being all that certain tract or parcel of land lying and situated in Polk County, Texas, being located in the I. G. N. R. R. SURVEY # 39, ABSTRACT No. 339, being a part or portion of that certain called 377.599 acre tract conveyed by Special Warranty Deed from EPC Holdings 791, LLC., to Rayonier Forest Resources, L.P., and recorded in the Official Public Records of Polk County, Texas (OPRPCT) in volume 1852 on page 689, dated July 27, 2012 referred to as 'Tract 405', to which reference is hereby made for any and all purposes and said tract being described by metes and bounds as follows to wit:

Commencing at a concrete monument found for the Southwest corner of the I. G. N. R. R. Survey # 37, A - 340 and the Southeast corner of the Jacob Perkins Survey, A - 477, same being the Northwest corner of said referenced 'Tract 405'; Thence along the calculated North boundary line of said 'Tract 405', same being the North boundary line of said referred to I. G. N. R. R. Survey #39, A - 339, S89°54'27"E at a distance of 2235.82 feet, intersect the West Rightof-way line of a railroad, a point for corner 57 feet from centerline of same; Thence along the said West Right-of-way line S24°06'21"W, a distance of 55.14 feet to the Point of Beginning of the herein described tract, a 1/2 in iron rod set for corner, 57 feet from centerline of railroad;

Thence along the West Right-of-way line of said railroad as shown on Right-of-way map for Houston East & West Texas RY. Co. C.E.43408 revised date December 31, 1930, S24°06'21"W, at a distance of 332.92 feet, the beginning of a curve to the left, a 1/2 in. iron rod set for corner, 57 feet from centerline;

Thence with said curve to the left, having a radius of 1966.86 feet, a central angle of 01°51'13", a long chord bearing and distance of \$20°58'21"W- 63.63 feet, at an arc distance of 63.64 feet, a 1/2 in. iron rod set for the Southeast corner of the herein described tract, 57 feet from centerline of railroad:

Thence leaving railroad and across 'Tract 405', N89°54'27"W, at a distance of 1395.86 feet, intersect the approximate centerline of a graded County Road locally known as Wheeler Road, a point for corner and from which a 1/2 in. iron rod set for reference bears S89°54'27"E -25.44 feet;

Thence along the approximate centerline of Wheeler Road, five (5), calls as follows:

- 1). N10°44'06"E, at a distance of 52.63 feet, a point for corner;
- 2). N12°31'36"E, at a distance of 27.50 feet pass a 1/2 in. iron rod set for reference, bearing S89°23'01"W - 25.67 feet, and at a total distance of 171.12 feet, a point for corner;
- 3).N15°53'41"E, at a distance of 89.47 feet, a point for corner;
- 4). N28°17'12"E, at a distance of 64.39 feet, a point for corner;
- 5). N35°23'00"E, at a distance of 2.30 feet, a point for corner;

Thence leaving said roadway, S89°54'27"E, at a distance of 30.63 feet, pass on line a 1/2 in. iron rod set for reference and at a total distance of 1451.33 feet, the Point of Beginning of the herein described tract and found to contain 11.950 acres more or less and of which, 0.219 acres lie within the margins of Wheeler Road. The bearings of this survey are based on the South boundary line of that certain called 82.5 acre tract as conveyed to James McClintock and recorded in the OPRPCT in volume 1449 on page 927 (S 89°54'27" E).
