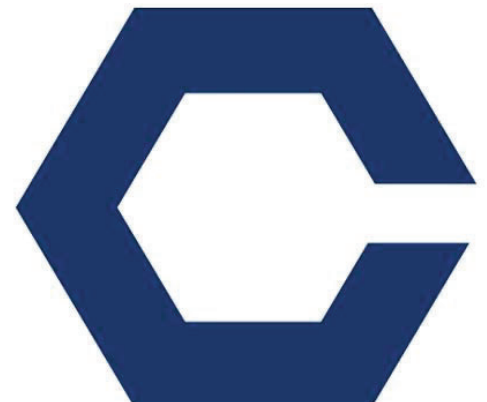

SERVICE AGREEMENT:

OWNER recognizes that soil conditions in this area are such that there may occur some future shifting of the soil. If any re-raising due to settling of the area of the structure on which CONTRACTOR performs the work, CONTRACTOR will re-raise settled areas where the above described pilings have been installed, without cost to OWNER for the lifetime of the structure. The removal and/or replacement of any type of floor covering for the adjustment of interior pilings shall be at OWNER'S expense.

The Lifetime Service Agreement does not cover any damage related to the settlement or the reraising of structure.

TRANSFERABILITY:

OWNER'S rights hereunder may be assigned to a purchaser of the property covered by this Agreement and all of the terms, provisions, and warranties provided herein shall be binding on CONTRACTOR, provided, however, OWNER or the purchaser must notify CONTRACTOR in writing of such transfer of ownership within thirty (30) days after the effective date of the transfer of title of the property and provide a fee of \$100.00 to transfer.

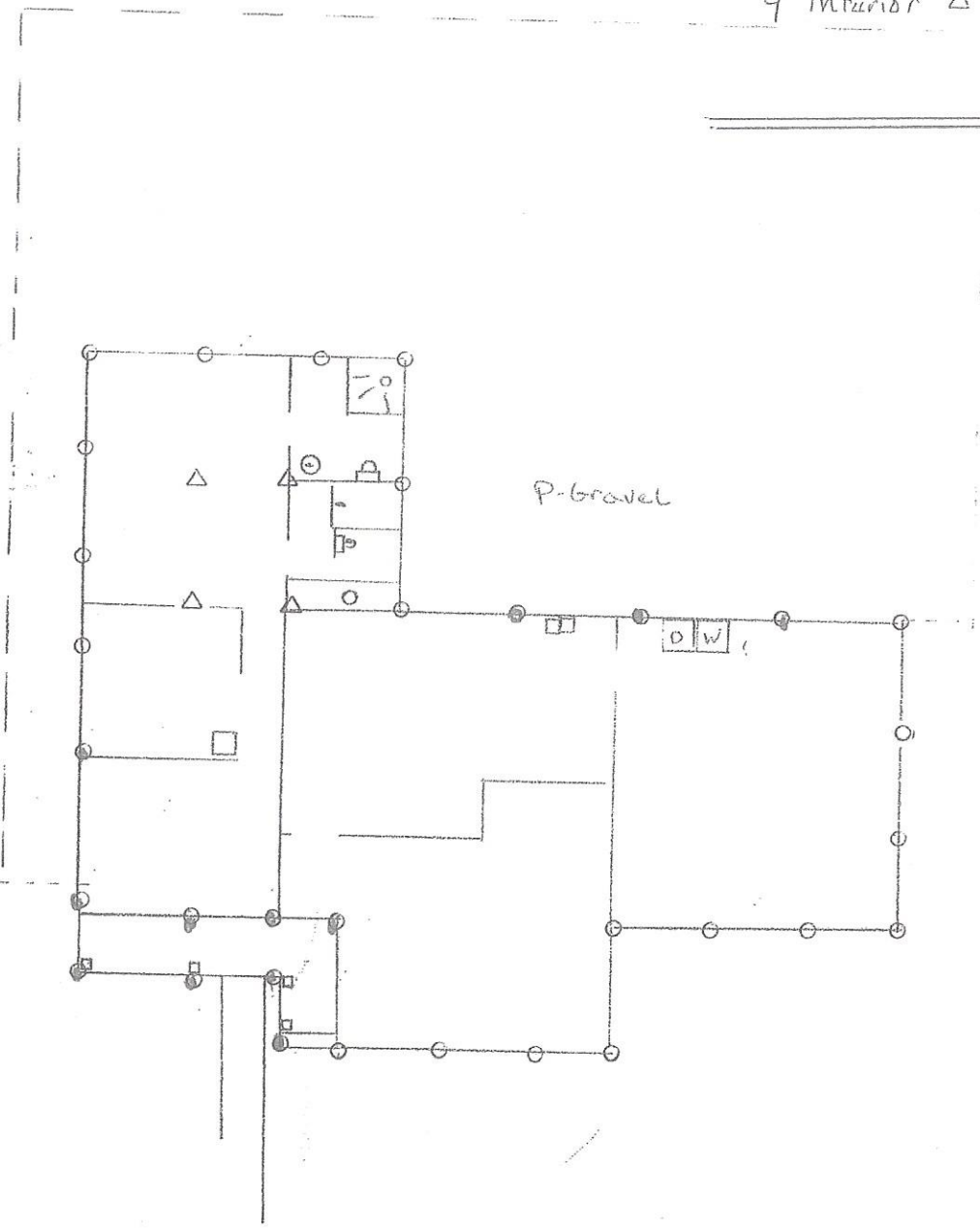
