Garage requires drywall, garage recreational room requires drywall, paint, and new interior door. Facia board strip (~5-6 ft length) on west side of house, south of carport, needs replacement.

House has been thoroughly cleaned and bleached at least 3 times. Seller has lived intermittently on property over past 2.5 years with no health issues.
