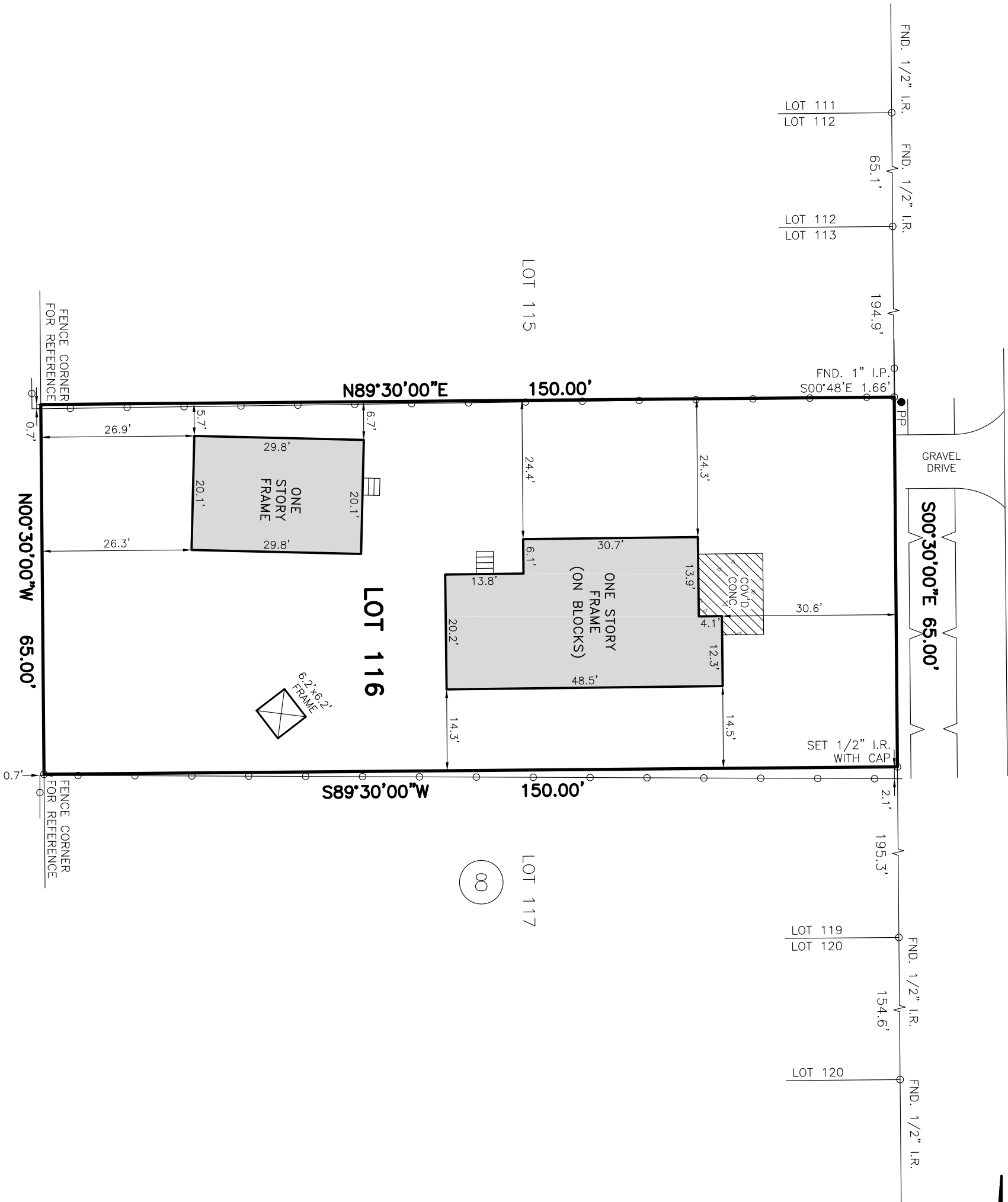





LOS ANGELES STREET
