

THENCE South 90° 00' 00" West (called West, basis of bearing) along said South line, being the North line of Outlot 253, a distance of 786.53 feet to a 1/2 inch iron rod found for the Southeast corner of a called 5.00 acre tract conveyed to Cheryl Owens by Deed recorded under Galveston County Film Code No. 013-87-1005;

THENCE North 00° 06' 45" West, parallel with the West right-of-way line of said Avenue "L" and along the East line of said Owens Tract, a distance of 330.00 feet to a ½ inch iron rod set for he Southwest corner of a tract of land conveyed to Randall and Deborah Byers by Deed Records under Galveston County Film Code No. 012-06-1986;

THENCE North 90° 00' 00" East (called East) along the South line of said Byers Tract, a distance of 786.53 feet to a 1/2 inch iron rod set in the West right-of-way line of said Avenue "L" for corner,
