BEGINNING at a one-inch iron pipe, found at the Northeasterly corner of the herein described tract and being a Southwesterly interior corner of the residual area tract out of Reserve "F" as described in Deed to Alfio Fichera, dated November 14, 1997 and recorded under Film Code 012-17-1544, O.P.R.P.G.C.T.:


Reserve "F" and passing at 4.00 feet, the Easterly Southwest corner of the Fichera tract and being the Northwesterly corner of a 0.0950 acre tract described in Deed recorded under Film Code 011-72-0955 O.P.R.R.P.G.C.T.; in all, a distance of 67.00 feet to a point in a gravel drive, being the Southeasterly corner of the herein described tract and Southwesterly corner of the 0.0950 acre tract, in the Northwesterly line of the H. D. Dampier 0.1628 acre tract as described in Deed dated April 27, 1984 and recorded under Clerk's File Number 8419598 O.P.R.R.P.G.C.T.; all as referenced by an iron pipe (not recoverable) in the roadbed of a 20 foot wide Ingress/Egress Easement described under Clerk's File Number 8731757 O.P.R.R.P.G.C.T.;

THENCE South 57°27'00" West, severing Reserve "F" along the Southeasterly line of the 0.1017 acre tract, passing at 15.82 feet, a point for the Northwesterly corner of the Dampier tract and the Northeasterly corner of the Lawrence E. Land 0.1004 acre tract as referenced and described under Clerk's File 8724127 O.P.R.R.P.G.C.T.; in all, a distance of 66.09 feet to a point for the Southwesterly corner of the herein described tract at the Northwesterly corner of the Lang 0.1004 acre tract, in the Northeasterly line of the Dave Family Limited Partnership, 0.1116 acre tract as described in Deed dated June 30, 1995 and recorded under Film Code 010-55-0808 O.P.R.R.P.G.C.T.; said corner being further referenced by two 5/8 inch iron rods as found bearing: South 33° East, 1.38 feet and South 57°27' West, 0.33 feet and South 33° East, 1.55 feet and South 57°27' West, 0.41 feet;

THENCE North 33°00'00" West along the Southwesterly line of the 0.1017 acre tract, severing Reserve "F" and passing at 7.0 feet, the Northeasterly corner of 0.1116 acre tract; passing at 14.0 feet, a point for the Westerly Southeasterly corner of the aforementioned Fichera tract; in all, a distance of **67.00 feet** to a one inch iron pipe, found for the Northwesterly corner of the herein described tract at an interior corner of the Fichera tract;

THENCE North 57°27'00" East, a distance of **66.09 feet** along the Northwesterly line of the 1.1017 acre tract and a Southeasterly line of the Fichera tract, back to the *Point of Beginning* and containing 0.1017 acre (4428 square feet) of land, based on the survey and plat prepared by Glezman Surveying, Inc., dated April 7, 2014.
