

METES AND BOUNDS DESCRIPTION

STATE OF TEXAS COUNTY OF AUSTIN

Being a 12.34 acre tract of land out of the B. M. Hatfield Survey, Abstract No. 184, Austin County, Texas and being all of Lot 132 and the remainder of Lot 133 of Piney Creek, Section III, a subdivision in Austin County per plat recorded in Volume 1, Page 27 of the Map Records of Austin County, Texas, said 12.34 acres being more particularly described by metes and bounds as follows;

BEGINNING at a 1/2 inch iron rod found at the northwest corner of said Lot 132, same being the southwest corner of Lot 131, located on the east line of Burlington and Santa Fe Rail Road, for the northwest corner of this;

THENCE along the north line of said Lot 132, common boundary with Lot 131 N 73°57'29" E passing a 1/2 inch iron rod found for reference at a distance of 553.84 feet and continuing a total distance of 584.05 feet to a calculated point in the center of Meadow Bend Road at the northeast corner of said Lot 132, being the southeast corner of said Lot 131, located on the west line of Lot 146, for the northeast corner of this;

THENCE along the east line of said Lot 132 and Lot 133, common boundary with said Lot 146, Lot 145 and Lot 144, and along the centerline of said road S 28°09'32" E a distance of 858.90 feet to a calculated point at the most easterly corner of the remainder of said Lot 133, same being the northeast corner of a called 0.279 acre tract to Timothy Scott Dement, (Clerk's File No. 6880), for the most easterly corner of this;

THENCE along the south line of the remainder of Lot 133, common boundary with said 0.279 acre tract S 45°25'16" W passing a 1/2 inch iron rod found at a distance of 491.18 fet and continuing a total distance of 492.10 feet to a calculated point at the south corner of the remainder of Lot 133, same being the northwest corner of said 0.279 acre tract, located on the northeast line of a called 26.242 acre tract to Paul B. Christian, et al, (Clerk's File No. 17005), for the south corner of this;

THENCE along the southwest line of said Lot 133, common boundary with said 26.242 acre tract N 49°29'23" W a distance of 174.88 feet to a 3/8 inch iron rod found for an angle point at the a northwest corner of said 26.242 acre tract, located on the east line of said rail road, for an angle point of this;

THENCE along the west line of said Lot 133 and Lot 132, common boundary with said rail road, the following courses and distances:

N 33°09'52" W a distance of 254.16 feet to a 3/8 inch iron rod found for an exterior el corner.

N 54°18'16" E a distance of 50.26 feet to a 3/8 inch iron rod found for an interior el corner, and

N 33°20'47" W a distance of 600.77 feet to the POINT OF BEGINNING.

All bearings and distances are based on State Plane Coordinate System, Texas Central Zone, Nad 1983.
