DAN RODES 12.438 ACRES TRACT ROBERT ARMOUR SURVEY, A-1 GRIMES COUNTY, TEXAS

FIELD Notes of a 12.438 acres tract or parcel of land lying and being situated in the Robert Armour Survey, A-1, Grimes County, Texas, and being 2.612 acres out of the called 4.698 acres Tract 205 and 9.826 acres out of the called 10.00 acres Tract W-47, both parent tracts being described in the Deed recorded in Volume 982, Page 687, of the Real Property Records of Grimes County, Texas, said 12.538 acres tract being more particularly described as follows:

BEGINNING at an iron rod found marking the southerly corner of the called 10.00 acres Tract W-47, said iron rod marking the westerly corner of the Donald Zotyka 10.00 acres Tract W-46 (538/144) and located in the northeast line of the Donald Zotyka 10.00 acres Tract W-31 (541/641);

THENCE N 39° 16' 12" W along the southwest line of the called 10.00 acres Tract W-47, same being the northeast line of the 10.00 acres Tract W-31, for a distance of 286.05 feet to an iron rod for corner marking the westerly corner of the called 10.00 acres Tract W-47, the northerly corner of the Tract W-31 and located in the southeast line of the called 4.698 acres Tract 205;

THENCE S 35° 49' 06" W along the southeast line of the called 4.698 acres Tract 205, same being the northwest line of the Tract W-31, for a distance of 260.39 feet to an iron rod for corner marking the southerly corner of the called 4.698 acres Tract 205 and the easterly corner of the Donald Zotyka 3.00 acres Tract 205 (598/608);

THENCE N 54° 13' 39" W along the southwest line of the called 4.698 acres Tract 205, same being the northeast line of the Tract 204, for a distance of 367.71 feet to an iron rod for corner located in the southeast right-of-way line of John Rice Drive (852/684 & 852/719);

THENCE N 35° 46' 20" E along the southeast right-of-way line of John Rice Drive for a distance of 299.65 feet to an iron rod for corner marking the westerly corner of the Dyer 1.88 acres tract (1276/59) out of the called 4.698 acres Tract; 205;

THENCE along the southerly lines of the Dyer 1.88 acres tract for the following calls:

S 53° 49' 38" E for a distance of 138.18 feet to an iron rod;

S 53° 09' 38" E for a distance of 112.41 feet to an iron rod;

S 82° 44' 56" E for a distance of 84.07 feet to an iron rod;

N 86° 29' 11" E for a distance of 55.48 feet to an iron rod;

N 35° 18' 56" E for a distance of 142.37 feet to an iron rod for corner located in the northeast line of the called 4.698 acres Tract 205, same being the southwest line of the Joseph Squires 8.00 acres Tract 206 (615/450), said iron rod marking the easterly corner of the Dyer 1.88 acres tract;

THENCE S 54° 13' 39" E along the northeast line of the called 4.698 acres Tract 205, same being the southwest line of the Squires Tract 206, for a distance of 1.89 feet to an iron rod for corner marking the easterly corner of the called 4.698 acres Tract 205, the southerly corner of the Squires Tract 206 and located in the northwest line of the called 10.00 acres Tract W-47;

THENCE along the common lines of the called 10.00 acres Tract W-47 and the Squires Tract 206, for the following calls:

N 35° 49' 06" E for a distance of 398.66 feet to an iron rod;

N 40° 20' 30" E for a distance of 498.34 feet to an iron rod for corner marking the northerly corner of the called 10.00 acres Tract W-47 and the westerly corner of the Gilbert Schultz 10.00 acres Tract W-48 (535/745);

THENCE S 21° 59' 51" E along the northeast line of the called 4.698 acres Tract W-47, same being the southwest line of the Schultz Tract W-48, for a distance of 356.49 feet to an iron rod for corner in the northerly right-of-way line of Stillmeadow Lane;

THENCE along the northerly and southwesterly right-of-way lines of Stillmeadow Lane, for the following calls:

Along a curve to the left having a radius of 50.00 feet for an arc distance of 139.98 feet, the chord bears S 12° 11' 56" E a distance of 98.54 feet, to an iorn rod;

S 39° 16' 12" E for a distance of 115.56 feet to an iron rod for corner
