## ARTICLES OF INCORPORATION

We, the undersigned natural persons of the age of twenty-one (21) years or more, at least two of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

### ARTICLE I

The name of the corporation is THE WOODFOREST ASSOCIATION. INC.

### ARTICLE II

The corporation is a Non-Profit Corporation.

## ARTICLE III

The period of its duration is perpetual.

## ARTICLE IV

The purpose or purposes for which the corporation is organized are:

- To govern the condominium property situated in Harris County, Texas, known as The Woodforest, Inc.,
- (2) In furtherance of the above, the corporation may make and perform contracts of every kind for any lawful purpose with any person, firm, association, corporation, municipality, state, government or municipal or political subdivision.
- (3) To have and exercise all the rights and powers conferred on non-profit corporations under the Texas Non-Profit Corporation Act, as such law is now in effect or may, at any time hereafter, be amended.

(4) To do all other acts necessary or expedient for the administration of the affairs and attainment of the purposes of this corporation.

This corporation is organized pursuant to the Texas

Non-Profit Corporation Act and does not contemplate pecuniary
gain or profit to the members thereof and is organized for
non-profit purposes.
