Introduction

These Rules and Regulations ("Rules") have been adopted by the board of Directors ("Board") of Woodforest Association, Inc. (the "Association") pursuant to the authority of and are subject to the Woodforest Association, Inc. Declaration ("Declaration"), the Bylaws of the Association ("Bylaws") and the Texas Condominium Act (Chapter 82 of the Texas Property Code; specifically Section 82.102

The following items are prohibited and will result in a fine according to the Association's Fine and Collection Policy:

- 1. Exiting through the entrance gate
- 2. Entering through the exit gate
- 3. Leaving Pedestrian Gates Open
- 4. Leaving Pool Gates Open
- 5. Pets Not on a Leash
- 6. Not picking up pet waste

- 7. No dumping heavy furniture
- 8. Food preparation and/or cooking, grilling or barbecuing is prohibited except within Common Areas designated for such purposes
- 9. Residents are solely responsible for the conduct of their guests

10. Leaving trash and rubbish outside your door on patio or porch.
