Item 10. 'E' — Utility easement 16 feet in width along the rear and northerly property line, and an unobstructed aerial easement, adjoining thereto, 5 feet 6 inches wide from a plane 16 feet above the ground upward, as shown by the recorded plat of said subdivision.

Item 10. 'F' — Utility easement 10 feet in width along the front property line, and an unobstructed aerial easement, adjoining thereto, 11 feet 6 inches wide from a plane 16 feet above the ground upward, as shown by the recorded plat of said subdivision.

Item 10.  ${\rm 'G'}-{\rm A}$  drainage easement 25 feet in width along the front property line of the subject property, as shown per the recorded Plat thereof.

Item 10. 'H' — A drainage easement 20 feet in width along the rear property line of the subject property, as shown per the recorded Plat thereof.

Item 10. 1' — A building setback line 100 feet in width across the front property line of the subject property, as shown per the recorded Plat thereof.

Item 10. 'J' — Does not affect tract.

Item 10. 'K' — Building set back line 100 feet in width along the front property line, as set forth by instruments recorded in Film Code No. 378014 of the Map Records of Harris County, Texas, and by instrument filed for record under Harris County Clerk's File No. S091500.

Item 10. 'L' — A building set back line 15 feet in width across the side and rear property line of subject property, as set forth in instrument filed under Clerk's File No. S091500 of Harris County, Texas

Item 10. 'M' — A utility and drainage easement 25 feet in width as defined in instrument of record under County Clerk's File No. S091500 of the Real Property Records of Harris County, Texas.

Item 10. 'N' — An easement 20 feet wide along the rear property line, as set forth in instrument filed for record under Harris County Clerk's File No. S091500.
