

Section 3: Is seller aware of any of the following conditions?

Termites: Around February 2020, homeowner discovered termites at the north front corner of the garage; no wood damage was visible. Homeowner spray-treated the area. This was the first time in 10 years homeowner had discovered any termite activity during quarterly homeowner inspections.

On 5/17/2020, evidence of termites was observed. Terminix did an inspection on 5/18/2020 and made professional recommendations for treatment. All recommendations have been followed. Treatment consisting of pressurized chemical spray and 14 bait stations (see additional documentation from Terminix) was completed on 5/21/2020. This treatment has a one-year warranty that remains with the home and is transferable to the next homeowner at no charge. Warranty covers reinspection and retreatment as recommended by Terminix.
