Theriot by instrument recorded in Document No. 161442 of the Official Public Records of Austin County, Texas, for the north corner of said 2.489 Acre Tract, (First Tract), same being the west corner of the herein described tract;

Thence, N 44°58'20" E, along the common line of said 2.489 Acre Tract, (Second Tract), a distance of 99.19 feet to a ½" iron rod found on the common line of that certain called 2.00 acre tract of land as conveyed to Ronald W. Klatt by instrument recorded in Volume 574, Page 417, of the Deed Records of Austin County, Texas, for the east corner of said 2.489 Acre Tract, (Second Tract), same being a corner of the herein described tract;

Thence, S 45°06'00" E, along the common line of said 2.00 Acre Tract, a distance of 19.73 feet to a ½" iron pipe found for the south corner of said 2.00 Acre Tract, same being a corner of the herein described tract;

Thence, N 44°48'00" E, along the common line of said 2.00 Acre Tract, a distance of 208.61 feet to a ¾" iron pipe found for the west corner of that certain tract of land as conveyed to Eleazar Jose Avalos and Wife, Alma Rosa Alvaros by instrument recorded in Volume 728, Page 652, of the Deed Records of Austin County, Texas, same being the east corner of said 2.00 Acre Tract, same being the north corner of the herein described tract;

west corner of that certain called 0.4733 acre tract of land as conveyed to Franklin Mericle and Wife, Kristina Shenae Theriot by instrument recorded in Document No. 133825 of the Official Public Records of Austin County, Texas, and continuing for a total distance of 307.11 feet to a 3/8" iron rod found on the common line of Evlyn Courts Condominiums, a subdivision in Austin County, Texas, according to the map or plat thereof recorded in volume 2, Page 157, of the Map Records of Austin County, Texas, for the south corner of said 0.4733 Acre Tract, same being a corner of the herein described tract;

Thence, S 45°00'00" W, along the common line of said Evlyn Courts Condominiums, a distance of 88.59 feet to a calculated point for the west corner of said Evlyn Courts Condominiums, same being a corner of the herein described tract, from which a ½" iron rod found for reference bears, S 55°24'19" E, a distance of 0.46 feet;

Thence, S 44°42'00" E, along the common line of said Evlyn Courts Condominiums, a distance of 408.57 feet to a 5/8" iron rod found on the northwesterly right-of-way line of Schmidt Road for the south corner of said Evlyn Courts Condominiums, same being the most easterly corner of the herein described tract;

Thence, S 45°15'10" W, along the northwesterly right-of-way line of Schmidt Road, a distance of 30.00 feet to the POINT OF BEGINNING and containing 2.4891 acres or 108,427 square feet of land, more or less.
