7. NO SMOKING IN INTERIOR OF HOUSE OR GARAGE.

8. NO BURNING OF UNATTENDED CANDLES.

9. NO EXCESSIVE NAILS IN WALLS.

10. DRUG FREE PREMISES.

11. PER LEASE, TENANT MUST CHANGE FILTER MONTHLY AT THEIR OWN EXPENSE. ANY REPAIRS NEEDED AS A RESULT OF NEGLIGENCE WILL BE TOTALLY AT THE EXPENSE OF THE TENANT AND PAYABLE WITHIN 30 DAYS OF THE INFRACTION.

13. TENANT RESPONSIBLE FOR ANNUAL PREVENTIVE PEST INSPECTIONS AND TREATMENTS, INTERIOR AND EXTERIOR.

14. NO UNAUTHORIZED STRUCTURAL/COSMETIC CHANGES MAY BE MADE TO PREMISES WITHOUT WRITTEN CONSENT FROM LANDLORD. IF IN VIOLATION, WILL RESULT IN THE FINANCIAL RESPONSIBILITY TO TENANT FOR THOSE DAMAGES TO BE REPAIRED AND PAYMENT WILL BE DUE WITHIN 30 DAYS OF INFRACTION.

15. ALL LIGHT BULBS WILL BE FUNCTIONING AT MOVE IN. TENANT RESPONSIBLE FOR CHANGING ALL LIGHT BULBS IN UNIT DURING TENANCY, AND UPON MOVE OUT, MAKING SURE ALL BULBS ARE IN WORKING ORDER.

16. YARD WILL BE MOWED EVERY TWO WEEKS. ALL BEDS WILL BE WEEDED AND MULCHED AT LEAST ONCE A YEAR. TREES AND BUSHES WILL ALSO BE TRIMMED AT LEAST ONCE A YEAR. THIS WILL BE AT THE TENANTS EXPENSE.
