

A tract or parcel of land being part of Lots 30, 31 and 32 of the S. V. Eaton Subdivision of the East ½ of Outlot 16, in the City of Galveston, in Galveston County, Texas, according to the map or plat of said S. V. Eaton Subdivision recorded in Volume 178, Page 190, in the Office of the County Clerk of Galveston County, Texas, said tract being more particularly described by metes and bounds as follows:

BEGINNING at a 2 inch metal post in the North line of said Outlot 16, being located South 73 deg 30 min 00 sec West, a distance of 195.25 feet from its Northeast corner;

THENCE South 73 deg 30 min 00 sec West, along the North line of said Outlot, a distance of 23.50 feet to a 2 inch metal post for corner;

THENCE South 16 deg 30 min 00 sec East, parallel to the East line of said Outlot, a distance of 100.00 feet to a ½ inch iron rod found for corner;

THENCE North 73 deg 30 min 00 sec East, parallel to the North line of said Outlot, a distance of 23.50 feet to a ½ inch iron rod found for corner;

THENCE North 16 deg 30 min 00 sec West, parallel to the East line of said Outlot, a distance of 100.00 feet to the POINT OF BEGINNING of the herein described tract of land.
