14.813 Acres

James Powell Survey, A-415 & The Anderson Worley Survey, A-606 Montgomery County, Texas

Being 14.813 acres of land, out of a called 26.772 acre tract, located in the James Powell Survey, A-415 and the Anderson Worley Survey, A-606, Montgomery County, Texas, according to the recorded deed thereof in County Clerk File #2003-154764 of the Deed Records of Montgomery County, Texas, said 14.813 acres being more particularly described by metes and bounds as follows:

BEGINNING at a 1/2" iron rod found in the north right of way of Johnson Road for the southwest corner of said 26.772 acre tract and herein described tract;

THENCE North 37 degrees 48 minutes 27 seconds West, with the westerly line of said 26.772 acre tract, a distance of 2,077.61 feet to a 5/8" iron rod found for the most southerly northwest corner of herein described tract;

THENCE North 14 degrees 40 minutes 12 seconds East, a distance of 23.65 feet to a 5/8" iron rod found for the most northerly northwest corner of herein described tract;

THENCE North 78 degrees 06 minutes 05 seconds East, a distance of 769.42 feet to 5/8" iron rod found for the northeast corner of herein described tract;

THENCE South 28 degrees 00 minutes 38 seconds East, a distance of 755.52 feet to a 1-1/2" iron pipe found for the most northerly southeast corner of herein described tract;

THENCE South 42 degrees 03 minutes 46 seconds West, a distance of 124.06 feet to a 1/2" iron rod found for an angle point of herein described tract;


THENCE South 52 degrees 11 minutes 33 seconds West, a distance of 430.16 feet to a 1/2" iron rod set for an angle point of herein described tract;

THENCE South 37 degrees 48 minutes 27 seconds East, a distance of 1,009.68 feet to a 1/2" iron rod set in the northright of way of Johnson Road for the most southerly southeast corner of herein described tract;

THENCE South 86 degrees 07 minutes 06 seconds West, with the north right of way of Johnson Road, a distance of 36.16 feet to the POINT OF BEGINNING of herein described tract, containing 14.813 acres of land.
