BEING A 1.2271 ACRE (53,454.15 SQ. FT.) TRACT OF LAND OUT OF A CALLED 1.4187 ACRE TRACT RECORDED UNDER MONTGOMERY COUNTY CLERK'S FILE NO. 2008101688, BEING THE OUT OF LOTS 376,377, AND 378, STAGECOACH FARMS, SECTION 9, MONTGOMERY COUNTY, TEXAS, AS SHOWN BY MAP OR PLAT RECORDED IN VOLUME7, PAGE 287, MAP RECORDS OF MONTGOMERY COUNTY, TEXAS; SAID 1.2500 ACRES BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS;

BEGINNING AT A SET 5/8 INCH IRON WITH FDS CAP MARKING THE SOUTHWEST CORNER OF THE INTERSECTION OF INDIAN SPRINGS TRAIL (60 FOOT RIGHT-OF-WAY) AND SINGLETREE DRIVE (60 FOOT RIGHT-OF-WAY), BEING THE NORTH EAST CORNER OF SAID 1.4187 ACRES, LOT 378 AND HEREIN DESCRIBED TRACT;

THENCE S 02°02'01" W, ALONG THE WEST LINE OF SAID SINGLETREE DRIVE, ALSO BEING THE EAST LINE OF SAID 1.4187 ACRES AND LOT 378 A DISTANCE OF 157.22 FEET TO A SET 5/8 INCH IRON WITH FDS CAP MARKING THE SOUTHEAST CORNER OF THE HEREIN DESCRIBED TRACT,

THENCE S 87°40'59"W, OVER AND ACROSS SAID 1.4187 ACRES AND LOTS 376, 377, AND 378, A DISTANCE OF 340.00 FEET TO A SET 5/8 INCH IRON WITH FDS CAP LYING IN THE COMMON LINE OF LOTS 375 AND 376 OF SAID STAGECOACH FARMS, SECTION9 MARKING THE SOUTHWEST CORNER OF THE HEREIN DESCRIBED TRACT;

THENCE N 02°02'01"W, ALONG SAID COMMON LINE, A DISTANCE OF 157.22 FEET TO A FOUND 1" IRON PIPE THAT BEARS N 87°40" E 1.0 FEET MARKING THE COMMON CORNER OF SAID LOTS 375 AND 376 AND LYING IN THE SOUTH LINE OF SAID INDIAN SPRINGS TRAIL AND BEING THE NORTH EAST CORNER OF SAID 1.4187 ACRES AND HEREIN DESCRIBED TRACT;

THENCE N 87°40'59"W, ALONG THE SOUTH LINE OF SAID INDIAN TRAIL, A DISTANCE OF 340.00 FEET TO THE **POINT OF BEGINNING** AND CONTAINING 1.2271 ACRE (53,454.15 SQ. FT.) OF LAND, MORE OR LESS,
