The home has superior structural support to a typical pier and beam home as there is also a concrete slab beam that supports the structure, located along the perimeter of the home. Additionally, given the siding runs all the way down to the concrete slab beam, this helps to minimize the possibility of any cats, raccoons or other animals going under the home. The one draw-back is that the crawl space is not easily accessible for repairs and only allows for a limited termite inspection. If a major repair would need to occur, blueprints are available that would identify the area to access.
