

1034 Hilbun Road, New Ulm, TX - Additional Information

The main Ranch House, a Texas Dog Trot theme, was designed in 1985 by John Perry Associates Architects for Robert and Marilyn Prejean. The foundation is pier and beam. The framing is 2x6s on 12 inch centers with cedar siding. We are the third owners, purchasing the home on April 21, 2004, and have the original blueprints.

We have made numerous improvements over the years including, but not limited to, the following:

2004 - Purchased and completely restored a longleaf pine one room Texas School House (approximately 1,000 square feet) originally located in neighboring Frelsburg, Texas. Added a wrap around porch and bathroom (approximately another 1,000 square feet under roof).

2004 - Relocated a hunting cabin which we reroofed, resided with cedar siding and used as a Garden Shed.

2005 - Added an air conditioned and heated Storage Building.

2005 - Built enclosed shed for pool equipment.

2005 - Added a Barn-like three car Garage with Shop, Loft Master Suite and a spacious extended roof on three sides (approximately 4,800 total square feet).

2006 - Built a covered 42 foot Dock with electrical and water service on seven acre lake.

2006 - Added Feed Barn at pens.

2007 - Added brick floored Green House with drip hoses for irrigation system.

2007 - Added a Pump House with an attached bathroom.

2007 - Added a 252 foot deep well for irrigation and as a backup for the main Ranch House well.

2007 - Added a 105 foot well with functioning windmill which feeds pond in front of Ranch House.

2008 - Added a 40x60 foot metal Hay Barn with sheds and stalls connected to cattle pens.

2008 - Professionally transplanted several additional live oak trees to ranch.

2010 - Fenced garden and added additional raised beds.

2012 - Added a Bunk House with kitchen, great room, master bedroom with private exterior entrance and ensuite bathroom, another bedroom with shower off the hall, a sleeping loft with two built in bunkbeds; queen beds on the bottom and extra long twins on top. Bunk House includes a front porch, side covered entry way patio, peach trees in the back yard and fire pit area out the front door near the pond. We have slept a dozen plus people in our Bunk House!

2012 - Added an approximately 1,000 square foot Gym with front porch.

2013 - Remodeled main Ranch House including, but not limited to:

- Added a two oven, six burner, Wolf stove and various cabinetry upgrades to the Kitchen
- Extended the Dinning Room and added eight foot sliding Anderson glass door with pool view
- Added a Media Room with Anderson sliding glass door with pasture view to the MBR Suite
- Added his and her walk in closets to MBR Suite
- Added half bath to the MBR Suite Media Room
- Added Vermont soap stone wood burning stoves to MBR Suite and Kitchen Breakfast Nook
- Replaced windows in Kitchen, Breakfast Nook and MBR Suite with double pane and double hung windows
- Replaced HVAC with Trane equipment and added a second buried propane tank for heating system
- Redid the septic system

2013 - Replaced pump on 252 foot deep well with a new 5hp 3 Phase pump.

2015 - Rebuilt East Dam of seven acre lake with construction grid polyethylene piping

2015 - Added a Chicken and Guinea Hen coop.

2016 - Added porch to MBR Suite, relocated hot water heater to ground level and added hot and cold water outdoor pool shower. Added instant hot water to entire house.

2017 - Replaced roof on Ranch House with standing seam steel roof by Schulte Roofing, Navasota, TX.

2017 - Rebuilt West Dam on seven acre lake as originally designed but using aluminum pipe instead of galvanized pipe.

2018 - Replaced Bunk House upstairs HVAC system.

2019 - Added water filtration system to Ranch House, Bunk House and School House.

2020 - Replaced all gates on Dock.
