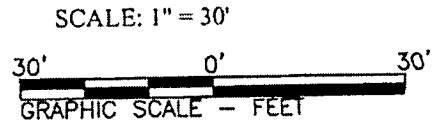


GENERAL NOTES

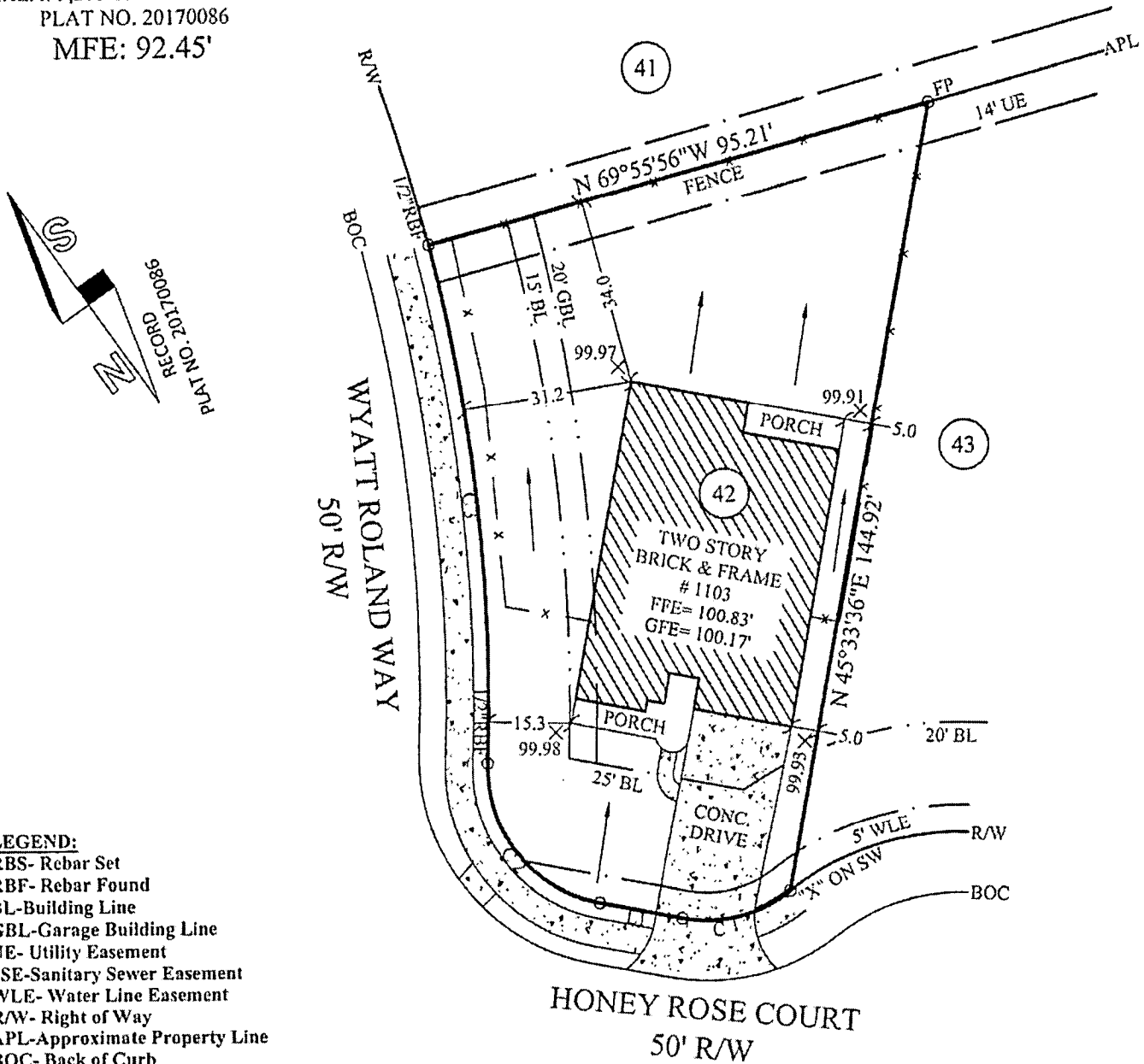

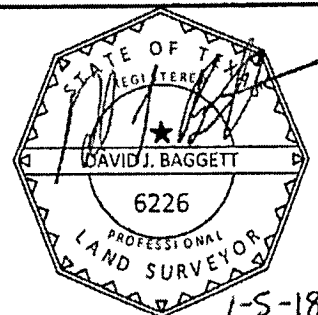
