BEGINNING at a 5/8" iron rod found in the eastern right of way of Penick Road (Unknown R.O.W.) for the northwest corner of the called 10.032 acres as recorded in Volume 713, Page 598 of the D.R.W.C., for the southwest corner of the called 10.101 acres, and marking the southwest corner of the herein described parcel;

THENCE, North 00° 05' 58" West, a distance of 232.00 feet along the eastern right of way of Penick Road to a 5/8" iron rod set with plastic cap for the most western southwest corner of the called 39.005 acres as recorded in Volume 802, Page 445 of the D.R.W.C., for the northwest corner of the called 10.101 acres, and marking the northwest corner of the herein described parcel;

THENCE, North 89° 54' 02" East, a distance of 832.75 feet along the southern line of the called 39.005 acres to a 5/8" iron rod set with plastic cap for the northwest corner of the called 4.83 acres (simultaneously conveyed), and marking the northeast corner of the herein described parcel;

THENCE, South 52° 39' 36" East, a distance of 384.88 feet along the western line of the called 4.83 acres to a 5/8" iron rod set with plastic cap in the northern line of the called 10.032 acres, for the southwest corner of the called 4.83 acres, and marking the southeast corner of the herein described parcel of land;

THENCE, West, a distance of 1138.34 feet along the northern line of the called 10.032 acres back to the **POINT OF BEGINNING** and containing 5.27 acres of land.

COMMENCING at a 5/8" iron rod found in the eastern right of way of Penick Road (Unknown R.O.W.) for the northwest corner of the called 10.032 acres as recorded in Volume 713, Page 598 of the D.R.W.C., for the southwest corner of the called 10.101 acres, and marking the southwest corner of the called 5.27 acres (simultaneously conveyed);

THENCE, East, a distance of 1138.34 feet along the northern line of the called 10.032 acres to a 5/8" iron rod set with plastic cap for the southeast corner of the called 5.27 acres, and marking the southwest corner of the herein described parcel of land, same being the **POINT OF BEGINNING**;

THENCE, North 52° 39' 36" West, a distance of 384.88 feet along the eastern line of the called 5.27 acres to a 5/8" iron rod set with plastic cap in the southern line of the called 39.005 acres as recorded in Volume 802, Page 445 of the D.R.W.C., for the northeast corner of the called 5.27 acres, and marking the northwest corner of the herein described parcel of land;

THENCE, South 00° 05' 58" East, a distance of 235.27 feet along the southern line of the called 39.005 acres to a 5/8" iron rod set with plastic cap for the northeast corner of the called 10.032

acres, for the southeast corner of the called 10.101 acres, and marking the southeast corner of the herein described parcel of land;

THENCE, West, a distance of 744.86 feet along the northern line of the called 10.032 acres back to the **POINT OF BEGINNING** and containing 4.83 acres of land.

THENCE, North 89° 54' 02" East, a distance of 832.75 feet along the southern line of the called 39.005 acres to a 5/8" iron rod set with plastic cap for the northwest corner of the called 4.83 acres (simultaneously conveyed), and marking the northeast corner of the herein described parcel;

THENCE, South 52° 39' 36" East, a distance of 49.35 feet along the western line of the called 4.83 acres to a point for the southeast corner of the herein described parcel;

THENCE, South 89° 54' 02" West, a distance of 871.93 feet to a point in the eastern right of way of Penick Road for the southwest corner of the herein described parcel;
