- Drywall shrinkage cracks and painting in various rooms

- Changed out three manufacturers recalled Vortens toilets with new Toto toilets
- Cleaned out dryer vent

Section 8, Question 8, supplemental clarification:

In late 2019, the front roof dormer commenced leaking in hard rain. Water affected a small area of sheetrock over the upper middle window in the dining room. Consulted with roofing contractor on source of leak. Based on his advice, old caulking around the exterior dormer joints was cleaned out and re-caulked by the homeowner. It was subsequently verified through heavy downpours the leak had been eliminated.

The affected sheetrock area was opened up approximately two months later by the above contractor. Everything was found to be dry and without any indication of mold. Out of an abundance of caution, some fiberglass insulation was removed, the behind sheetrock area was sprayed with a mold inhibition solution, allowed to dry and the insulation was replaced with new material. A sheetrock section was replaced, taped, textured and repainted.
