The purpose of the inspection is to determine if there are large amounts of mold contents, if any which can cause health problems.


During the inspection, a visual inspection and Indoor Air Quality Test was conducted. The 1<sup>st</sup> stage of the inspection was by checking all exposed studs and seal plates for moisture and to determine if they are dry. The 2<sup>nd</sup> stage of the inspection was setting up and using the environmental monitor machine throughout the house to check for mold spores and other environmental issues that can be harmful. The 3<sup>rd</sup> stage of the inspection was by sealing and packing the allergenco samples to be delivered to the lab.

There were 2 air samples taken throughout the house, such as in the Formal Living Room, Master bedroom and Outside. 75 liters each taken indoors and 75 liters outside. The Allergenco Samples were delivered to J3 Resources Lab.

The results from J3 Resources Lab conclude that the mold raw count appears to be low throughout the house, due to the front door that open and close routinely, but the overall report show that you are clear to close your walls.

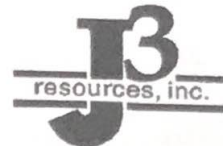
My recommendation is to maintain a temperature of the mid 70's throughout the house and to keep the return filters replaced on a monthly schedule after the repairs have been made. I strongly recommend the ac evaporator coil in the attic to be cleaned by a licensed HVAC Repairman.
