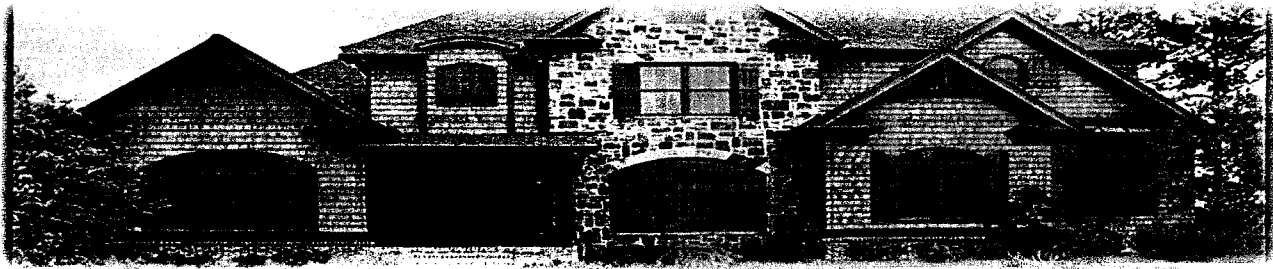

This agreement does not obligate the property owner(s) or Sienna Home Services in any way unless the claim is approved by the property owner's insurance company AND accepted by Sienna Home Services. By signing this agreement, the property owner(s) authorize(s) Sienna Home Services to pursue the property owner(s) best interest for property replacement or repair at a "price agreeable" to the property owner's insurance company and Sienna Home Services. When "agreed price" is determined, it shall become the final price which is the RCV amount on the insurance paperwork plus the applicable contractor's overhead and profit AND any supplements that follow. The property owner(s) authorizes Sienna Home Services to obtain labor and materials in accordance with the "agreed price" and specifications set out here in this agreement and on the reverse side hereof to complete the replacements or repairs agreed upon. Property owner(s) acknowledge(s) Sienna Home Services as the general contractor on file and as such will be entitled to 10% overhead & 10% profit as allowed by insurance industry standards. All work will be performed at insurance company rates, figures and money. Property owner(s) is responsible for his/her deductible. Also, property owner(s) acknowledge that he/she has read the front and back of this agreement and fully understand the terms of this agreement.
