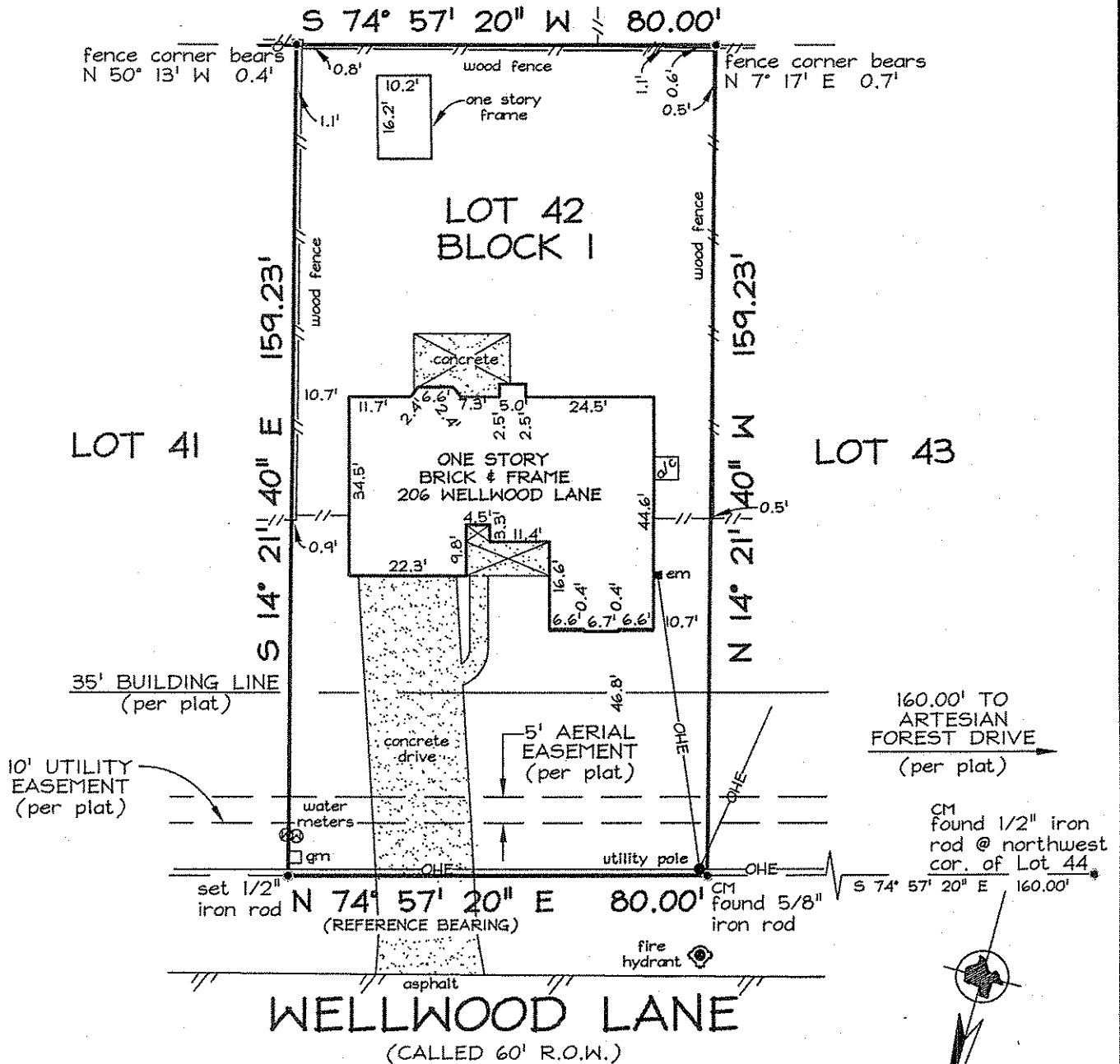


GARWOOD HILLS

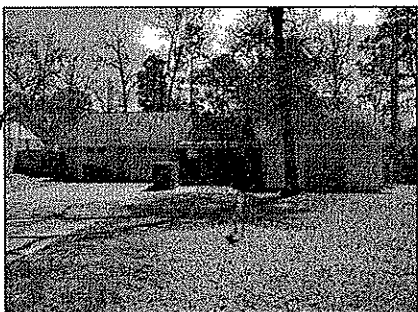

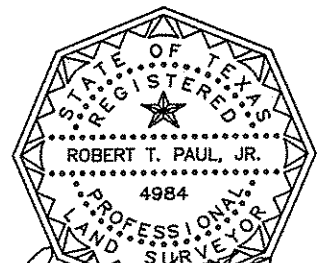
