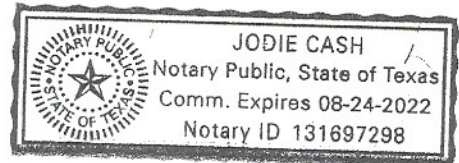
4. **To the best of our actual knowledge and belief, since** June 4, 2013 there have been no:
