Previous roof appears to have leaked as their are signs of old ceiling drywall repair in the theater and main bedroom. Column spalling and honeycombing was repaired/patched. Some old rotten wood on decks, stairs, and handrails was replaced and some connections were reinforced.



"Reservoir" means a water impoundment project operated by the United States Army Corps of Engineers that is intended to retain water or delay the runoff of water in a designated surface area of land.


