All that certain tract or parcel of land lying and being situated in Grimes County, Texas, out of the Uriah Sanders Survey, Abstract No. 408, the B.B.B. & C.R.R. Survey, Abstract No. 119, being a part of a called 221.35 acre tract as described in a Special Warranty Deed from Texas Municipal Power Agency (TMPA) to Weslie R. Marks, dated December 13, 2000, of record in Volume 965, Page 824 of the Real Property Records of Grimes County, Texas and more fully described as follows:

COMMENCING at a found 5/8 inch iron rod, at the base of a 6 inch by 6 inch treated fence corner and an 8 inch treated fence corner, for the Northerly Northwest corner of the called 221.35 acre tract mentioned above, a Southwest corner of a called Lot 1, Carlos Lakes (1052/641 – per plat), a Southwest corner of a called 10.000 acre tract (Lot 1) as described in a Deed to Donald Reese Booker (1381/390) and same being in the Easterly ROW of FM Highway 3090 (80 ft. ROW (194/62 & 194/65));

THENCE S 22°13'13" W, 265.32 ft., to a found 1/2 inch iron rod with cap, at the base of a 3 inch iron pipe fence corner post, for the Westerly Northwest corner of a called 20.00 acre tract as described in a Deed to David Gochnour, et ux (1574/100), in a counterclockwise curve in the Southeast ROW of FM Highway 3090, the Northerly Northeast corner and the **TRUE PLACE OF BEGINNING** of the tract of land herein described,

THENCE S 03°28'43" E, along the fenced and West line of said 20.00 acre Gochnour tract (1574/100) and **PASSING** at 909.43 ft. a found 1/2 inch iron rod, on the North side of a 3 inch iron pipe fence corner post for reference, **PASSING** at 2,173.52 ft. a found 1/2 inch iron rod in said fence line for the Southwest corner of said 20.00 acre Gochnour tract and a Northwest corner of a called 50.00 acre tract as described in a Deed to David Gochnour, et ux (1574/100) and continuing along its fenced West line for a **TOTAL DISTANCE** of 3,134.05 ft. to a found 1/2 inch iron rod on the Northeast side of a 4 inch iron pipe fence corner post for its Southwest corner;

THENCE N 86°31'17" E, 1,260.55 ft., along the fenced and South line of said 50.00 acre Gochnour tract (1574/100) to a found 1/2 inch iron rod, 8.3 ft. East of a 4 inch iron pipe fence corner post in a barbed wire fence line, for its Southeast corner, in an East line of the called 221.35 acre tract mentioned above and same being in the West line of a called 42.43 acre tract, more or less, as described in a Deed to Jeff W. Sullivan, et ux (1062/252);

THENCE S 04°06'33" E, along the East line of the called 221.35 acre tract mentioned above, the West line of said 42.43 acre Sullivan tract (1062/252) and **PASSING** at 290.43 ft. a found 1/2 inch iron rod 1.54 ft. left of or East of this line for its called Southwest corner and same being the called Northwest corner of a called 173.097 acre tract as described in a Deed to Charles F. White, III, et ux (1695/436) and continuing along its generally fenced and West line and the East line of the 221.35 acre tract mentioned above for a **TOTAL DISTANCE** of 1,584.24 ft. to a found 3 inch iron pipe, at fence corner, for its Southeast corner, the Southwest corner of said 173.097 acre White tract and same being in the North line of a called 211.80 acre tract as described in a Deed to Milton S. Allen (298/876);

THENCE S 85°39'15" W, 1,557.42 ft., along the generally fenced and South line of the called 221.35 acre tract mentioned above and the North line of said 211.80 acre Allen tract (298/876) to a set 1/2 inch iron rod, 6.2 ft. North of a 4 inch by 4 inch square iron fence corner post, for the Southwest corner of the tract of land herein described, from which a found 3 inch iron pipe, at fence corner, for the Southwest corner of said 221.35 acre tract mentioned above brs. S 85°39'15" W, 818.24 ft.;

THENCE following a new net wire fence line crossing through the 221.35 acre tract mentioned above located on the Westerly lines of the tract of land herein described as follows:

- N 02°37′02" W, 46.20 ft., to a found 5 inch iron pipe fence corner post for an interior corner of the tract of land herein described;

to a set 1/2 inch iron rod for the Westerly Southwest corner of the tract of land herein described; THENCE S 87°10'47" W, 457.18 ft., along a partly fenced South line of the tract of land herein described

to a set 1/2 inch iron rod, in a field and on the West side of a pond, for an angle point in line for corner; THENCE N 07°26'05" W, 393.28 ft., along a non fenced West line of the tract of land herein described

to a set 1/2 inch iron rod, in a net wire fence line, for an angle point in line for corner; THENCE N 01°06'49" E, 1,275.81 ft., along a non fenced West line of the tract of land herein described
